State Treasurer of the State of Kansas, in the City of Topeka, Kansas, And said County of Douglas, in the State of Kansas, is held and firmly bound by these presents, and the full faith, credit and resources of said County are herety irrevocably pledged for the prompt payment of said principal and interest at maturity.

This Bond is one of a series of Thirty (30) bonds of like date and tenor, excepting as to maturity, numbered from one (1) to thirty (30), issued for the purpose of providing funds to pay the cost of acquiring, establishing and completing a public park and recreational ground in Douglas County, in full compliance with the provisions, restrictions and limitations of the constitution and laws of the State of Kansas, including Article 1 of Chapter 10, G. S. Kansas, 1935, and Chapter 194 of the 1937 Session Laws of Kansas, and all acts amendatory and supplemental thereto, and such bonds and all interest thereon are to be paid by Douglas County, Kansas.

And it is hereby declared and certified that all acts, conditions and things required to be done and to exist precedent to and in the issuance of this bond, have been properly done and performed and do exist in due and regular form and manner as required by the constitution and laws of the State of Kansas, and that the total indebtedness of said County, including this series of bonds, does not exceed any constitutional or statutory limitation.
