Section 1. That for the purpose of providing funds for the care and maintenance of the poor dependent upon the public for support in said County, there shall be issued, and hereby are issued, Public Assistance Fund Eends of Douglas County, Kansas, in the principal sum of \$15,000. Said issue shall consist of fifteen bends, numbered from One to Fifteen, inclusive; each of said bends being in the sum of \$1000. All of which bends; shall be dated October 1, 1.37, and said bends shall become due serially as follows:

Said bonds numbered One to Six shall bear interest at the rate of Two and one-fourth per cent $(2\frac{1}{2}\frac{1}{2})$, and bonds numbered Seven to Fifteen shall bear interest at the rate of Two and One-Half per cent $(2\frac{1}{2}\frac{1}{2})$ per annua, payable semi-annually on the first days of April and October in each year. Both principal and interest of said bonds shall be payable at the office of the State Treasurer of the State of Hansas, in the City of Topeka, Kansas.

And said County of Douglas, in the State of Kansas, is held and firstly beund by those presents, and the full faith, credit and resources of said County are hereby irrevocably plodged for the prompt payment of said principal and interest at maturity.

This bond is one of a series of Fifteen (15) bonds of like date and tenor, excepting as to maturity and interest rate, numbered from One (1) to Fifteen (15) inclusive, amounting in the aggregate to Fifteen Thousand Dollars (\$15,000), issued for the purpose of providing for the care and maintenance of the poor dependent upon the public for support in Douglas County, Kansas, and in full compliance with the provisions, restrictions and limitations of the constitution and laws of the State of Kansas, including Sections 10-101 to 10-116, inclusive and Section 39-3a04 G. S. Kansas 1935, and all acts amondatory supplemental thereto, and Chapter 244 of the 1937 Session Laws of the State of Kansas, and such bonds and interest thereon are to be paid by Douglas County, Mansas.

And it is hereby declared and cortified that all acts, conditions and things required to be done and to exist precedent to and in the issuance of this bond, have been properly done and performed and do exist in due and regular form and manner as required by the constitution and laws of the State of Kansas, and that the total indebtedness of said County, including this series of bonds, does not exceed any constitutional or statutory limitation.
