The Board of County Conmissioners, upon call of the Undirman, convened as a board of Social Welfare in the Social Welfare Department to confer with the County Director and assistants on welfare cases.

The Board directed the Gounty Clork to publish a road notice in the official county paper for the viewing of said road on November 10, at 2 o'clock P. M., at the place of beginning.

Beek, informed the Board of the request made by Mr. Allon French, auditor, for the recording of the fidelity bonds of the county officials in the Register of Deeds office. If such proceedure is to be carried out, he stressed the need of a book for the recording of said bonds.

Final disposition on purchase of a book was deferred until a later date.

Mr. Bock told the Commissioners that he is in almost immediate need of a new chattel index, and discussed with the Board the purchase of same.

After some discussion, the Board Informed Mr. Back to consult the County Clerk, Furchasing Agent for the County, and have the County Clerk order the record as specified by the Register of Deeds.
