NOVEMBER 3, A.D.1937.

The Board of County Commissioners met in adjourned regular session November 3, A.D.1937, with all the Commissioners, namely, Chris Schaake, Chairman, Earl T. Black and James F. Brass, members, and T. R. Gerhart, County Clerk, present.

Further BILLS and CLAINS against the County were presented and allowed as per Allowance Record.

Mr. FRED DESKINS appeared before the Board, wanting to donate some rock to the County for rocking the road north of the Stull Road, past the Bill Buchheim place.

No action was taken by the Board on this.

Mr. DANIEL E. DAHLENE, Wirer for the Rahskopf Plumbing Shop, came before the Board relative to the matter of defects in the wiring for the lighting of the bridge. Mr. Dahlene thoroughly and clearly explained the causes contributing to the difficulty, and outlined the remedy.

The Board went over the matter in detail with Mr. Dahlene and took it under advisement, deferring action until a later date.



BIDS for the AUDIT of the COUNTY OFFICES for 1937 were opened and read, (five in all). There were present in this behalf the County Auditor, Mrs. Mildred LeSuer; Messrs. Rutledge, Henry and French, representing respectively the bidding firms of John C. Shepard & Company, Topeka; Brelsford & Cifford Company, Topeka, and Allen French, Topeka. W. C. Hail & Company, of Lawrence, and A.R. Jones & Company, of Topeka, also submitted bids.

The matter was gone over thoroughly by all parties, and action deferred until a later date.

PETITION from EVERETT BOND and eleven others for the straightening of a Cemetery Road was here presented, with the O.K. of County Engineer Trueblood.

It was moved by Mr. Black and seconded by Mr. Brass that this road petition be accepted and be advertised according to law. The motion was then put by the Chairman and unanimously adopted. The date of hearing was set for November 24, 1937, at 2:30 P.M.

The Board of County Commissioners here adjourned and met as a Board of Social Welfare to consider the application of Osburn McCleery for increased assistance. Mrs. Mildred Watson, County Director, was called in, and the matter gone into carefully.

The Board ruled to take the case under consideration and see what could be done.

Following the noon recess, the Board met in the Social Welfare Department and took under consideration applications for old age assistance.

The Osburn McCleary case was assigned to the Case Worker for consideration.

The Board, returning to its chambers, re-convened as the Board of County Commissioners.



Mr. C. C. STEWART, Attorney, representing petitioners for the PAVING of EMERY ROAD, appeared, and submitted four petitions for the consideration of the Board. There were present in connection with this project Mr. Stewart as attorney, Mr. George Hedrick and Prof. Frank L. Brown, representing the property owners interested; Mr. B. M. Babb, City Engineer, and Mr. Charles A. Springer, County Attorney.

The matter was gone over at length by the representatives of the petitioners and the Board, and it was suggested by Mr. Black that the Township Board have a representative attandant at the adjourned regular session Saturday, November 6th, and the matter be taken up again on that date, at 2:00 P.N. It was so ordered.

No further business appearing, adjournment was taken to November 6th, 1937.
