COMMISSIONER'S RECORD M

NOVEMBER 6th. 1937.

The Board of County Commissioners met in adjourned regular session November 6th, A.D.1937, with all members and the County Clerk in attendance.

Further BILLS and CLAIMS against the County were presented and allowed as per Allowance Record.

The matter of DEFECTS in WIRING for lighting the Bridge was again taken up.

The Board instructed the County Clerk to contact Mr. Prentice, of the Kennedy Plumbing Company, (the company that originally did the work), and ascertain the cost of correcting the faulty conditions that exist. Mr. Gerhart, the County Clerk, to report at the adjourned regular meeting of Wednesday, November 10th.

Mr. ELIJAH JAY came before the Board relative to some drainage problems affecting his farm. No action was taken on this.

The Board here adjourned to meet as a Board of Social Welfare, for the consideration of matters under the jurisdiction of such board.

Miss Irene Schaake, Home Visitor, came before the Board relative to assistance for WILLIAM PETTT

It was decided to allow \$20.00 in this case.

Mrs. Mildred D. Watson, County Director, conveyed the request of Mr. CHAS. GOODGER that the County pay for the extraction of three of his teeth. Mrs. Watson reported that Mr. Goodger had a very serious heart condition that necessitated the use of considerable digitalis.

The Board authorized Mrs. Watson to allow this dental bill.

Mrs. Watson submitted the application of Mr. Frank E. HARVEY for increased relief.

It was ordered that relief in this case be raised from \$13.00 to \$20.00.

Mrs. Watson reported the need of WARP for the making of blankets.

It was ordered that the cost of this warp be allowed

Mrs. Watson also reported that Mr. HEN FLESHMAN wanted a jack upon which to repair his shoes, stating that he had in sight a good secondhand one for \$10.00, accord-ing to Mr. Fleshman's appraisal.

The Board advised that, pending decision, someone from the Relief Office should investigate the quality and condition of the jack in question.

In the ALFRED LEEMAN case from Mrs. Watson's department, the \$5.00 sent by Mr. Leeman was ordered deducted from the regular monthly amount.

In the matter of the application for the sending of HELEN GENTRY, a bright fifteen-year-old girl, to the TB Hospital at Norton,

The Board, with the proper motion, second and wote, ordered that this be done

Mr. SAMUEL HOLLIDAY, who is eligible for old-age assistance, appeared before the Board, protesting a lien against his property.

: Mr. Holliday was assured that he would be protected, and was advised to rest easy until more information could be secured by the Board. <u>The Board adjourned</u>, to re-convene as the Board of County Commissioners. The matter of PETITIONS for the PAVING of EMERY ROAD was here taken up, there being present in this behalf Mr. C. C. Stewart, Attorney for the petitioners; Mr. E. E. Trueblood, County Engineer; Mr. B. M. Babb, City Engineer, and Messre. Ed. Johnson, Frank Topping and Fred O. Peterson, members of the Board of Wakarusa Township.

Mr. Babb presented a map showing minutely the actual routes covered in these peti-tions, and the matter was gone over in detail by representatives of the petitioners and Board.

The four following Resolutions for the projects were presented by Mr. Stewart for adoption:-

RESOLUTION

WHEREAS, Douglas County, Kansas is a county in Kansas having a population of more than 20,000 inhabitants, and WHEREAS, <u>Emery Road</u>, extending from the north line of University Drive to the south line of West Hills Parkway,

Drive to the south line of West Hills Parkway, is a public road in Douglas County, Kansas, lying entirely outside the limits _f any incorporated city, and WHEREAS, at least fifty per cent. of the property abutting upon the above-described road is platted and laid out into lots and block, and WHEREAS, a petition signed by the owners of more than sixty per cent. of the unplatted frontage on the above described road and by the owners of a sufficient percentage of the platted land abutting on said road to make more than fifty-one per cent. of the total frontage platted and unplatted has been filed, petitioning The Board of County Commissioners of the County of Douglas, State of Kansas, to improve said road by the construction of a re-enforced concrete pavement 26 feet interval. wide, including integral curb, together with the necessary grading and drainage,
