intervals; and to provide the County with such information as may be requested.

11. To prepare agreement for any portion of the work that may be sub-let, and to provide adequate inspection of all materials to be used on the work, receiv-ed by and from any party, or parties, sub-letting portions of the work. (This item refers in particular to ready-mixed concrete.)

12. To cooperate in any reasonable manner, not herein outlined, with W.P.A. representatives, County representatives, or authorized parties from other sources, which may tend to improve and increase the efficiency of the work.

TERMS: Terms for the above outlined services shall be four (4) per cent. of the total project cost, as determined by the total expenditures from all sources and values contributed, as shown on the application to the W.P.A., plus or minus any variance of equipment and labor, and variance of material costs based on the exact time and material expended; plus \$250.00 per month for supervision.

Two (2) per cent. of the estimated cost of the work shall be due the engineer when the plans and specifications are prepared, submitted to the W.P.A. and authorization of the work is secured from the W.P.A. An amount necessary to provide a whole amount of four (4) per cent. of the final pro-ject cost, when the work is complete and opened to the use of the public.

Supervision costs shall not exceed a period of six (6) months under the whole Blanket Project to be provided, nor more than four (4) months for any project submitted under the Blanket Project. Supervision costs shall begin when actual work begins, and to end when all work is completed.

It is expressly understood and agreed that no charge will be made for engineering services until actual work has been authorized by the W.P.A. and that should the work be halted for reason unforeseen, and the work dis-continued as a W.P.A. project, claim will be made, based on the portion constructed only; provided however the work is not continued with other funds.

ACCEPTANCE: This Proposal when accepted by resolution and signed by the Board of County Commissioners of Douglas County, Kansas, shall become a binding contract between Douglas County and B. M. Babb.
