The Board took the matter under advisement, for decision at an early date.

Mr. ERNEST KLOOZ came before the Board with a proposal to bring up to date the delinquent tax sales subject to foreclosure under the law, in preparation for foreclosure proceedings.

The Board postponed decision on Mr. Klooz's proposal for a short time.

Mr. FRANK LUTZ appeared relative to the matter of straightening the cemetery road adjacent to his farm, complaining that ten feet off the east side of his land is desired, which he does not wish to relinquish unless necessary.

The Board promised to visit the premises and look the matter over before making final decision.

The Board here re-convened as a Welfare Board.

Mrs. MILDRED WATSON, County Director, appeared before the Board and presented the request of Mr. Winston Smith that the Board purchase for him a wooden leg. Mrs. Watson reported that the man could and would work if he had the wooden leg, and that he stated he could then secure employment in Kansas City at once, and would not need relief.

The purchase of this wooden leg for Mr. Smith was authorized by the Board.

On proper motion, second and vote, adjournment was taken to Wednesday, November the 17th, 1937.

November 20, A.D. 1937.

The Board of County Commissioners of Douglas County, Kansas, met in adjourned regular session on Saturday, the 20th of November, 1937, with all members and the County Clerk present.

The Board sat as a Board of Social Welfare, and Mrs. MILDRED D. WATSON, County Welfare Director, appeared before it, stressing the need of an additional Case Visitor and recommending the appointment of Miss Irene Schaafe in this capacity. Mr. Brass made the following motion:-

In view of the fact that it is recommended to the Board that Miss Irene Schaafe be put on as a regular Case Home Visitor, having apprenticed as a trainee for three months, and having worked in the Relief Office here about two months prior to this apprenticeship, I move that Miss Schaafe be appointed as a regular Case Home Visitor, at a salary of \$75.00 per month.

Motion seconded by Mr. Black.

The Chairman put the motion, and by unanimous vote of the Board, it was so ordered.

Messrs. GUS BERGER and R. O. BURGERT, representing the City Council, and Mr. J. W. Stone, City Clerk, appeared, relative to removing the dead trees in the city. They reported possibly 12,000 dead trees to be cut down.

After discussion of the matter with the Board, it was agreed to have Charles Edmondson, City Forester, John Shores, Foreman of the County wood yard, and the City Fire Chief, take full charge of this matter.

The matter of Bids for Lumber for repair of the LECOMPTON BRIDGE was here taken up, and the following gentlemen appeared in this behalf:-

Mr. C. A. Lampman, representing the Wheeler Lumber, Bridge & Supply Co.; Mr. C. N. Jacquemin, Oskaloosa, and Mr. C. W. Hess, County Engineer of Jefferson County, representing Jefferson County in the letting.

Mr. Trueblood, County Engineer, was also present.

The bids of the L. R. Eaton Lumber Company, - - \$37.00 per M ft., and Wheeler Lumber, Bridge & Supply Co., \$37.25 per M ft., were

opened and read.

In view of the fact that the Wheeler Lumber Company insures delivery in approximately thirty days, and the Eaton Company in from four to six weeks, and possibly longer, and, further, the fact that it is imperative the lumber be delivered as soon as possible, it was deemed advisable to accept the bid of the Wheeler Lumber, Bridge & Supply Company.

Mr. Jacquemin moved that the lumber be purchased from the Wheeler Lumber, Bridge & Supply Company. Mr. Black seconded the motion.

Motion carried by unanimous vote.

It was agreed between the representatives from Jefferson County and the Board of County Commissioners of Douglas county that each county bear half the expense of the lumber.
