WHEREAS, an estimate has been filed by the engineer in charge, estimating the total cost of said improvements to be \$23,725.53, and said estimate has been approved by The Board of County Commissioners of the County of Douglas, State of Kansas,

Be it Resolved that the Board of County Commissioners of the County of Douglas, State of Kansas, issue temporary notes under authority of Section 10-123 of the General Statutes of Kansas for the year 1935 in a total sum of \$13,500.00, and that the same be sold from time to time for the purpose of obtaining money with which to pay for the cost of said project as payments therefor become due.

That such temporary notes be in the denomination of \$1,000.00, numbered from 1 to 13 inclusive, and one note for \$500.00 numbered 14. That each of said notes be dated the 6th day of January, 1938; that they be due two years from the date thereof, but payable sooner at the option of The Board of County Commissioners of the County of Douglas, State of Kansas, when funds from the sale of bonds to be issued to pay the cost of such improvements be available therefor; that such notes bear interest at the rate of  $3\frac{1}{2}$  per cent per annum, payable semi-annually on the 6th day of each January and July after the date thereof and read as follows:

KNOW ALL MEN BY THESE PRESENTS:

That The Board of County Commissioners of the County of Douglas, State of Kansas, a municipal corporation, for value received, does hereby acknowledge itself to be indebted to, and promises to pay to the bearer hereof, the sum of \$1,000.00 in lawful money of the United States of America, on the 6th day of January, 1940, or the due date of the first installment of bonds to be issued for the payment of the improvements hereinafter mentioned, as may be sooner in point of time, together with interest thereon at the rate of  $3\frac{1}{2}$  per cent per annum, payable semi-annually on the 6th day of January and the 6th day of July of each year after the date hereof, until the principal sum hereof shall be fully paid, both principal and interest of this note being payable at the office of the Treasurer of Douglas County, Kansas, in the City of Lawrence, Douglas County, Kansas, and the Board of County Commissioners of the County of Douglas, State of Kansas, is held and firmly bound by these present, and the full faith, credit, and resources of said Board of County Commissioners are hereby pledged for the prompt payment of said principal and interest at maturity.

This note is one of a series of notes in the total amount of \$13,500.00 issued for the purpose of evidencing indebtedness heretofore duly authorized by The Board of County Commissioners of the County of Douglas, State of Kansas for the making of certain improvements, to-wit, the paving, curbing, grading and drainage of West Hills Parkway, Emery Road, Stratford Road, and University Drive under a project designated as "West Hills Roads and Adjacent Roadways, Work No. W.P.A. 6346," which improvements are to be paid for in part by the issuance of bonds, under the authority of G. S. 68-728, and this note, as well as all other notes of this issue, are issued under the authority of, and in conformity with, the provisions, restrictions, and limitations, of the Constitution and laws of the State of Kansas, and specifically authorized by G. S. 10-123, being of the General Statutes of Kansas for the year 1935, and this note, together with all interest to become due thereon, is to be paid by said The Board of County Commissioners of the County of Douglas, State of Kansas.

The Board of County Commissioners of the County of Douglas, State of Kansas, reserves the right to pay this note at any time prior to the maturity date hereof.
