The Douglas County Board of Commissioners met in adjourned session this 19th day of January, 1938, with all members of the Board and the County Clerk present.

The first business of attention was the disorganization of the Board of County Commissioners.

By a motion, seconded and voted, Chris Schaake, the present Chairman of the Board, was named to continue to serve as the Chairman of the Board for the year 1938 and Earl T. Black serve as Vice-Chairman for the year 1938.

By the proper motions, seconds and votes, the following appointments were made:

E. E. Trueblood, the present County Engineer, was re-appointed County Engineer for the year 1938, at a salary of \$175.00 per month.

Mildred D. Watson was re-appointed County Director in the Social Welfare Department for the county of Douglas, for the year 1938.

Mrs. Mildred LeSuer was re-appointed Auditor of the County.

J. F. Metskor was re-appointed to continue in his capacity as Superintendent of the County Farm at the wage of \$60.00 per month and Mrs. Pearl E. Metskor to continue as Matron of the County Home at her present wage of \$65.00 per month.

Consideration for increase in wages for the Road and Bridge employees was discussed at this time. After considerable discussion on the matter, the following wage scale was adopted:
