COMMISSIONER'S RECORD M

CONTRACT

This AGREEMENT, entered into this 31st day of January, 1938 by and between the Board of County Commissioners of Douglas County, Kansas, Party of the First Part, and Barasdall Refining Corporation of Kansas City Missouri, Party of the Second Part, for the furnishing of gasoline for the period of one year from February 1, 1938 to February 1, 1939.

The Party of the Second Part agrees to furnish and deliver by and through its tank wagons or trucks, all of the gasoline requirements of the Party of the First Part, to points in Douglas County as required, throughout the contract period, at the following prices:

Be Square Gasoline, of the grade commonly referred to as "regular", having a minimum quality of not less than 60-62 gravity, 70-72 Octane, at the posted Tank Wagon Consumer price at time and place of delivery, less a discount of \$0.0159 per gallon.

Barnsdall Motor Fuel, of the grade commonly referred to as "third grade gasoline" having an Octane rating of 62 and below, at the posted Tank Wagon Consumer price at time and place of delivery, less a discount of \$0.01 per gallon.

Prices shall include all transportation charges to points of delivery. Payment will be made by Party of the First Part in regular routine upon receipt of invoices properly prepared and submitted to the County Engineer.

All prices are not and not subject to any further discount.

The Party of the Second Part agrees to fill all orders with reasonable promptness, but shall not be held responsible for losses resulting from delays in filling orders or making delivery by reason of partial or total interruption of transportation, fires, strikes, difference with workmen, interference of civil or military authority; or any causes beyond its control. This contract shall be subject to revision should any of its provisions be found to conflict with any existing or future law, rule or regulation. The Buyer or Seller may terminate this contract by giving 10 days notice in writing to the other party of his or its intention to do so.
