Arising before the Board, the awarding of contract for the official county printing for the year 1938 provoked considerable discussion by the Commissioners. Finally, the following resolution was passed and submitted to the Journal World:

WHEREAS, the matter of the awarding of the contract for the official printing for Douglas County for the year 1938, came on for consideration, and

WHEREAS, the Board of County Commissioners of Douglas County, Kansas, is desirous of accepting the bid of the Journal World Company, heretofore received, with certain provisions set out;

NOW, THEREFORE, BE IT RESOLVED by the Board of Douglas County, Kansas, that the Journal World bid of \$1.00 per square em for 1st insertion and 50¢ for subsequent insertions, for all legal printing except the delinquent and final tax lists, be accepted with the provision that the total sum for the year March 1, 1938 to March 1, 1939 for said printing shall not exceed \$1500.00 and further providing that the line space shall not be more than 35,080 count lines, which is double the number of lines used during the preceding year.

The Douglas County Board of Commissioners met in regular adjourned session with the County Clerk present in its regular meeting rooms in the Douglas County Court House.

Further bills for supplies, materials and wages for the county, and bills from the Social Welfare office were presented to the Commissioners, and duly passed after close inspection of each.

The County Engineer E. E. Trueblood discussed several matters pertaining to the Lone Star Park.

Dolph Simons, Business Manager of the Journal World Co., presented in writing his acceptance to the proposal formerly submitted by the County Commissioners pertaining to the awarding of the contract for the county's legal printing for 1938. The acceptance in letter form follows:

Board of Commissioner, Douglas County, Lawrence, Kansas.

Gentlemen:

The Journal-World appreciates your acceptance of our bid of \$1.00 per square of 250 ems for first insertion and \$.50 per square for succeeding insertions of same copy, for all regular legal printing except delinquent and final tax lists, and we agree to abide by your provision that the total charge for such printing from March 1, 1938 to March 1, 1939 will not exceed \$1500, providing the total amount of such printing does not exceed 33,080 count lines which is double the number of lines used in the preceding year according to the estimate of the Douglas County Auditor.

It was moved by James F. Brass that the Journal World Company be designated the official county paper with certain provisions set out heretofore, for all legal printing for the year 1938 with the exceptance of the delinquent and final tax list. A second was made by Earl T. Black, and on proper vote by all Commissioners in the affirmative, the motion carried.

It was further moved by James F. Brass that the contract for the delinquent tax list be let to the Lawrence Democrat for the year from March 1, 1938 to March 1, 1939. Seconded by Black and voted, the motion carried.

Mrs. W. O. Hamilton, Supervisor of the Sewing Room Project with Mrs. Watson, County Director, made a detailed report to the Commissioners on Federal Projects in Douglas County; and, also, at this time, stressed several needs for the Colored Children's Nursery.
