ACREEMENT RELATIVE TO REPAIR OF THE EUDORA-WAKARUSA RIVER BRIDGE

This AGREEMENT entered into this 23rd day of March, 1938, by and between Douglas County, through its Board of Commissioners, C. Schaake, Chairman, Earl T. Black and Jas. F. Brass, Commissioners; Party of the First Part, and the City of Eudora, through its City Council, J. D. Adams, Mayor, Chas. Schehrer, Dr. C. B. Johnson, Frank Summers, Geo. Lothholz and Geo. Trefz, Councilman; Party of the Second Part.

In which party of the first part agrees to furnish all tools and equipment, all materials, consisting of lumber, paint and hardware; and all labor and supervision necessary to remove old portions of the structure; clean and paint the steel work, and replace all portions of the timber work required for the complete repairs of the above mentioned bridge.

The party of the second part agrees to pay to the party of the first part, onehalf the total cost of the work within sixty days after date of completion.

The estimated cost of the work exclusive of cleaning and painting is \$605.70; and if painting is included, it is \$745.75. This cost data is only an estimate, and settlement will be made on the actual expenditures on the job.

A Mr. Kerns, former County Clerk, presented to the Board a picture of the three Commissioners, who sat as the first Board of County Commissioners to hold office in the new court house when it was built in 1903. The picture now hangs in the County Commissioners' room.

Pertaining to a claim for gasoline against the county by the Barnsdall Refining Corp., W. C. Foreman of Kansas City and John Ulm,Agent in Lawrence met with the Board, in order to clarify a discrepancy in the accounts.

An application for the admission of Joseph H. Brazabon, to the T. B. Sanatorium at Norton, was presented to the Board.

It was moved by Barl T. Black that the Chairman of the Board be authorized to sign the necessary application papers for the sending of one Joseph H. Brazabon to the State Hospital for T. B. at Norton. James F. Brass seconded the motion. On vote, put by the Chairman, all Commissioners voted "Aye".

County Clerk, Gerhart, presented a contract of the Monroe Calculating Machine Company for servicing of the three calculating machines in the court house, servicing to be from April 1, 1938 to April 1, 1939 at the price of \$66.00.
