In a special meeting, called this 15th day of April, 1938 by Chris Schaake, Chairman, all members of the Board and the County Clerk met in the regular meeting rooms of said Board, for the specific purpose of a detailed discussion on the welfare budget, as formerly set up.

Present during the discussion were Mildred LeSuer, County Auditor, Mildred D. Watson, County Director, and Chas. A. Springer, County Attorney.

A detailed discussion was gone into with reference to the probability of actual f expenditures exceeding the budget allowances as set up in said budget for the relief year 1938

It was finally decided that a deficiency is apt to appear; and that such action should be taken to remedy this. Fursuant to same, the following resolutions were

RESOLUTION PASSED AT MEETING OF THE BOARD OF COUNTY COMMISSIONERS OF DOUGLAS COUNTY, KANSAS, CONVENED AS THE BOARD OF SOCIAL WELFARE, HELD ON APRIL 15, 1938.

WHEREAS, Douglas County has levied for the year 1938 for social welfare purposes 2.54 mills on a valuation of \$35,932,077.00 and has extended on the 1937 tax rolls a total of \$91,267.47 as a result of said 2.54 mills levy; and

WHEREAS, there was made an issue of \$12,000.00 in Public Assistance Bonds, said issue being dated December 1, 1937, from which there remained an unexpended balance of \$6,827.66, which unexpended balance is available for 1938 social welfare expenditures, and amount equivalent to an additional .19 mill levy for social welfare purposes, and

WHEREAS, it further appears that there will be a deficiency of expenditures over resources for the year 1938, as evidenced by revised budget estimates for said social welfare purposes.

NOW, THEREFORE, BE IT RESOLVED by the Board of County Commissioners of Douglas County, Kansas, sitting as the Board of Social Welfare, that an extraordinary need for social welfare purposes exists in said County and that available revenues will not meet the county's need for social welfare purposes as defined in Chapter 327, Session Laws of 1937 and the said Board does hereby request that the said State Board of Social Welfare pay to Douglas County in addition to the amounts now paid, such amounts as the County may be entitled to under House Bill 130, Legislative Session of 1938.

<u>RESOLUTION</u>

WHEREAS, under House Bill No. 105 of the Special Session Laws of Kansas, 1937, the Board of County Commissioners are empowered by resolution to direct the County Treasurer to credit all or any portion of the County's share of such sales tax distribution as a political subdivision to the County's Social Welfare Fund or to a bond and interest fund to be used in the payments of bonds and interest thereon theretofore issued to obtain funds used in carrying on 'social welfare activities, and

direct the County Treasurer to credit all of its share from said distribution to the the County's Social Welfare Fund for use of social welfare purposes during the current county budget year, 1938.

NOW, THEREFORE, BE IT RESOLVED by the Board of County Commissioners as the Board of Social Welfare of Douglas County, Kansas, that the County Treasurer be and is hereby directed to credit all of its share as a political subdivision of sales
