By motion, duly made, seconded and voted, the foregoing resolutions were approved and passed.

A Mr. Stevens, who has completed team work on garden plots for the county met with the Commissioners to discuss his claim for such work. His claim was that he worked 35<sup>1</sup>/<sub>2</sub> hours at 62,5<sup>2</sup>/<sub>2</sub>, which makes a total of \$22.18. The Board discussed the matter thoroughly and finally approved said claim for payment.

Sitting as the Board of Social Welfare, the Commissioners of Douglas County, met with the County Director to attend to matters coming under the jurisdiction of said Board.

Again, appearing before the Board came Leroy Harris, Attorney for John Ireland, who has previously made application for Old Age Assistance, said application not, as yet, having been accepted.

The Board considered the matter thoroughly, and after a detailed discussion on same, made final decision as follows: Said John Ireland's case is not accepted for Old Age Assistance because two of the three affidavits pertaining to age, presented, were by the sisters of said John Ireland. Therefore, birth of the aforesaid applicant, was not satisfactory verified to comply with the State Board of Social Welfare authorization of eligibility for Old Age Assistance.

Further welfare cases for old age, dependent childron and general assistance were presented to the Board by members of the Welfare Department engaged in investigation of same. Passage and approvals on same were made by the said Board of Social Welfare.

Adjournment was taken by the Board.

The Board of County Commissioners of the County of Douglas, State of Kansas, met in special session called by the Chairman for the purpose of considering a resolution for the issuance of bords in connection with the paving and otherwise improving Crescent Road and Strong Avenue, and to consider, also, other matters, with all the mombers of the Board and the County Clerk, T. R. Gerhart, present.

On motion of Mr. Black, seconded by Mr. Brass, the following resolution was adopted by unanimous vote:

## RESOLUTION

WHEREAS, the Board of County Commissioners of the County of Douglas, State of Kansas, has heretofore authorized the making of certain improvements in the paving, curbing, grading, and drainage of Strong Avenue and of Crescent Road, being roads outside the limits of any incorporated city and being adjacent to the City of Lawrence, in Douglas County, Kansas, which county has a population in excess of 20,000 inhabitants, the cost of such improvements, other than that paid by the United States of America, to be assessed against the property abutting thereon, and

WHEREAS said improvements have been made and that part of the total cost to be assessed against the abutting property has been determined and special assessments made therefor; that notice has been given to such property owners of such special assessments and thirty days have passed and certain of said assessments are not yet paid, and

WHEREAS temporary notes have been heretofore issued for the purpose of paying the cost of such improvements as payments became due, such temporary notes, other than the part thereof paid from funds allowed by the United States and from special assessments collected, to be paid by the issuance of bonds of Douglas County, Kansas, and

WHEREAS the amount for which the Board of County Commissioners of the County of Douglas, State of Kansas, is liable for the above mentioned improvements and the amount for which bonds are to be issued to cover such liability have been determined to be the sum of \$18,000.00,

BE IT RESOLVED that the Board of County Commissioners of the County of Douglas, State of Kansas, issue and sell coupon bonds of said County of Douglas and State of Kansas in said amount of \$18,000.00. That said bonds be dated the 1st day of April, 1938; that interest be paid semi-annually thereon; and that the denomination of such bonds, the maturity dates, and the rates of interest be as follows:
