

COMMISSIONER'S RECORD M

April 28, 1938.

In special session, called by the Chairman of the Board, the Commissioners of Douglas County with the County Clerk assembled in the regular meeting rooms of said Board, for the specific purpose of discussing the designating of boundaries for voting precincts in the townships of the County.

The first action of the day was a motion made by James F. Brass that the Board rescind the resolution passed as of April 27, pertaining to the changing of boundaries and designating precincts of certain townships. Earl T. Black seconded the motion. On vote, put by the Chairman, the motion carried.

A very thorough discussion was gone into on the above matter, and after considerable deliberation, Earl T. Black moved that Palmyra Township, Lecompton Township and Wakarusa Township be divided into voting precincts as set out in the foregoing resolution. Further moved that T. R. Gerhart, County Clerk, publish the said resolution as passed on this day in lieu of a former resolution passed on April 27, 1938. Chris Schaeke seconded the motion. On vote, put by acting Chairman James F. Brass, all Commissioners voted "Aye".

NOTICE OF RESOLUTION PASSED BY THE BOARD OF COUNTY COMMISSIONERS
OF DOUGLAS COUNTY AT A SPECIAL CALLED MEETING ON
APRIL 28, 1938.

WHEREAS, under Chapter 223 of the Session Laws of Kansas, 1937, the Board of County Commissioners are empowered and authorized when they deem it necessary, to establish more than one precinct in any township in its county, and

WHEREAS, said Board of County Commissioners of Douglas County after due consideration of the matter of voting precincts in the townships in said county deem it necessary to establish more than one precinct in Lecompton, Palmyra and Wakarusa Townships in Douglas County.

NOW, THEREFORE, BE IT RESOLVED by the Board of County Commissioners of Douglas County, Kansas, that Lecompton Township be and is here by divided into two precincts bounded and designated as follows:

Beginning at the Southeast corner of Section 18, Township 12 S, Range 18 E; thence West along the South line of Lecompton Township to the West line of Douglas County; thence North along said County Line to the Kansas River; thence in a Northeasterly direction along the Kansas River to the East line of Section 30, Township 11 S, Range 18 E; thence South to the point of beginning. Said precinct to be known as Big Springs precinct of Lecompton Township.

Beginning at the Southeast corner of Lecompton Township; thence West along said township line to the Southwest corner of Section 17, Township 12 S, Range 18 E; thence North to the Kansas River; thence Southeasterly along the Kansas River to the East line of Lecompton Township; thence South on said Township Line to the point of beginning. Said precinct to be known as Lecompton precinct of Lecompton Township.

BE IT FURTHER RESOLVED that Palmyra Township be and is hereby divided into four precincts bounded and designated as follows:

Beginning at the Southwest corner of Palmyra Township; thence North to U.S. Highway No. 50; thence East two miles along said Highway; thence South one-half mile; thence East along High Street in the City of Baldwin City to the intersection of U.S. Highway no. 50 with High Street; thence along said U.S. Highway No. 50 to the Northeast corner of Section 11, Township 15 S, Range 20 E; thence South to the Douglas County line; thence West along the South line of Douglas County to the point of beginning. Said precinct to be known as South Baldwin precinct of Palmyra Township.

Beginning at the Southwest corner of Section 31, Township 14 S, Range 20 E; thence North on the West line of Palmyra Township to the Northwest corner of Section 19, Township 14 S, Range 20 E; thence East to the Northeast corner of Section 21, Township 14 S, Range 20 E; thence South to the Southeast corner of Section 21, Township 14 S, Range 20 E; thence East to the Northeast corner of the Northwest Quarter of Section 25, Township 14 S, Range 20 E; thence South to U.S. Highway 50; thence West to the Northwest corner of Section 12, Township 15 S, Range 20 E; thence Northwest along U.S. Highway 50 to intersection with High Street extended; thence West along High Street to the Southwest corner of the Northwest Quarter of Section 4, Township 15 S, Range 20 E; thence North to U.S. Highway No. 50; thence west along said Highway to the point of beginning. Said precinct to be known as North Baldwin precinct of Palmyra Township.

Beginning at the Southwest corner of Section 13, Township 15 S, Range 20 E; thence North to U.S. Highway No. 50; thence East along said Highway one-half mile; thence North to the Northwest corner of Northeast Quarter of Section 25, Township 14 S, Range 20 E; thence East to the Southeast corner of Section 19, Township 14 S, Range 21 E; thence North to the Northwest corner of Section 17, Township 14 S, Range 21 E; thence East to Douglas County Line; thence South along said County Line to the Southeast corner of said county; thence West along said county line to point of beginning. Said precinct to be known as Black Jack precinct of Palmyra Township.

Beginning at the Southwest corner of Section 18, Township 14 S, Range 20 E; thence North on the West line of Palmyra Township to the Northwest corner of said Township; thence East along the North line to the Northeast corner of said Township; thence South on said Township Line to the Southeast corner of Section 12, Township 14 S, Range 20 E; thence East to the Northeast corner of Section 18; Township 14 S, Range 21 E; thence South to the Southeast corner of Section
