valuations set by said taxing authorities, and

WHEREAS, said valuations for the years, 1934, 1935, 1936 and 1937, set by the Appellee on the Sigma Chi Fraternity structure, exclusive of land was \$39,200; and the valuations set by Appellee on the Chi Omega Fraternity exclusive of land was \$31,325, and

WHEREAS, it now appears to the Board of County Commissioners of Douglas County, Kansas, that a fair valuation for the years 1934, 1935, 1936 and 1937 is in the sum of \$33,620 on the Sigma Chi structure, exclusive of land; and \$27,855 on the Chi Omega structure, exclusive of land, and

WHEREAS, it is the desire of the Board of County Commissioners, to settle said causes by fixing valuations above stated on said structures in the amounts above stated.

NOW, THEREFORE, BE IT RESOLVED by the Board of County Commissioners, of Douglas County, State of Kansas, that Charles A. Springer, County Attorney and Attorney for said Board, stipulate in said causes that the valuation of the Sigma Chi structure, exclusive of land, be fixed at \$33,620; and the valuation of the Chi Omega structure, exclusive of land be fixed at \$27,855; which valuations shall apply for the years beginning 1934, through and including 1941; and that said Appellants pay taxes for the last four years on said valuations and without penalties; and said appeals to be dismissed at the cost of the Appellants.

On this 6th day of June, 1938, the Commissioners of Douglas County met as a Board in regular adjourned session in the regular meeting rooms of said Board with Chairman Chris Schaafe, Commissioners Earl T. Black and James F. Brass and County Clerk T. R. Gerhart, present.

Judge L. H. Menger appeared before the Board for a discussion on several matters.

T. F. Yost, State Weed Supervisor, met with the Board and the County Agent to discuss the Bindweed situation as it exists in Douglas County. A detailed discussion was gone into concerning the Program to be set up for said county, including therein the Bindweed budget. Pursuant to same, the following resolution was passed:

RESOLUTION FOR ADOPTION
OF BINDWEED PROGRAM FOR
DOUGLAS COUNTY

WHEREAS, the Session Laws of Kansas, 1937, states that the Board of County Commissioners shall control the spread of and to eradicate all weeds declared by legislative action to be noxious on all lands owned or supervised by them of which, field bindweed is declared to be a noxious weed, and

WHEREAS, said Session Laws states that methods for the above purposes shall be those as approved and adopted by the State Board of Agriculture, and

WHEREAS, complying with same, the Board has set up a program for eradication, plan and organization, for the County of Douglas, State of Kansas.

NOW, THEREFORE, BE IT RESOLVED that the program for eradication, plan and organization, relative to bindweed in Douglas County, in form as on file in the County Clerk's office, shall be and is hereby adopted by the Board of County Commissioners of said county and state.
