

## COMMISSIONER'S RECORD M

July 1, 1938.

In regular session, the Board of County Commissioners of Douglas County, Kansas, assembled in the regular meeting rooms of said Board, with all members and the County Clerk present.

Appeared Frank Fitzpatrick to discuss office space needed in connection with the Inventory project, and, also, supplies to be furnished by the county.

By motion, properly seconded and voted, claims against the county for welfare purposes, and claims of the employees of the county, were passed as recorded on record in the County Clerk's Office.

The final audit report of all county offices for the fiscal year 1937, was submitted to the Board by Allen French, Auditor. Whereupon, considerable time and discussion was given to same. County Auditor Mildred LeSuer was also present at this time.

Upon completion, it was moved by Earl T. Black that the final audit report, as submitted by Auditor Allen French, be accepted by the Board. A second was made by James F. Brass, and on vote, called by the Chairman Chris Schaaake, all Commissioners voted "Aye".

It was suggested by said Auditor that he send out notices to all delinquent Personal Property tax payers in Douglas County in an effort to get such delinquencies cleared up. James F. Brass moved that the Auditor, Allen French, be authorized to send out said notices to delinquent Personal Property tax payers in the county of Douglas. Earl T. Black seconded the motion. On vote, motion carried.

The Board of County Commissioners adjourned to meet July 5, 1938, at 9:30 A. M.
