July 18, 1938.

The Commissioners of Douglas County convened this day to sit as a Board with all members, namely: Chris Schaaake, Chairman, Earl T. Black and James F. Brass, Commissioners and T. R. Gerhart, County Clerk present.

A committee in the interest of the National Guard, met with the Board as per appointment previously given. Said committee being: Lieutenant Lansing, Harry Frazee, R. B. Stevens, George Hedrick, Sam Moyer and Henry Asher.

The object of the meeting was to determine if the County would be willing to contribute to each of the three units of National Guard in Douglas County, a certain sum of money to be used by said units for extra expenses that occur. The Committee made mention that the City of Lawrence now contributes \$75 to each unit. An account of the merits of the National Guard was given by members of the committee.

The Board deemed it advisable to take the matter under advisement before it rendered any decision on the matter.

Representatives from eight bonding houses met in the meeting rooms of the Board of County Commissioners to bid viva voce on West Hills Road Improvement bonds. Auction procedure was gone into with Chairman of the Board acting as auctioneer. After completion, Estes and Company remained with a bid of par and accrued interest, plus a premium of \$9.01 per \$1000 bond.
