The application of Earl Tuttle for a beer license, came on for consideration of the Board. No written objection having been received, the Board passed the following resolution:

RESOLUTION

WHEREAS, on the 21st day of July, 1938, the same being a regular adjourned meeting of the Board of County Commissioners, the application of Earl Tuttle for a beer license came on for consideration of said Board, and

WHEREAS, the Board does find that the said Earl Tuttle is in all ways qualified under the law to sell cereal malt beverages for consumption on the premises, and

WHEREAS, the Board further finds that a due and legal notice has been given to the Grant Township Board, and that ten days have expired from the giving of said notice, and that no written objection has been filed by the Grant Township Board, protesting the granting of a beer license.

NOW, THEREFORE, BE IT RESOLVED that the applicant Earl Tuttle be granted a license to sell cereal malt beverages for consumption on premises at the place so described in application.

BE IT FURTHER RESOLVED that T. R. Gerhart, County Clerk of Douglas County, be, and he is hereby directed to issue said license.

A delegation of the Lawrence Women's Club, consisting of about ten women, appeared before the Board for an appointed meeting to confer with the Board and the County Attorney on reducing the assessed valuation of said club, and on the abatement of taxes against same. Arguments were presented as to why they considered the purchase price of \$8000.00 a fair valuation, and why the taxes levied against the property for 1937 should be abated.

Bids were received for reinforcing bars for the Stull Bridge over Deer Creek.
