WHEREAS, The Board of County Commissioners of the County of Douglas, State of Kansas, has heretofore authorized the making of certain improvements in the paving, curbing, grading, and drainage of Emery Road, West Hills Parkway, Stratford Road, and University Drive, as described in the proceedings in connection therewith, being roads outside the limits of any incorporated city and being adjacent to the City of Lawrence, in Douglas County, Kansas, which county has a population in excess of 20,000 inhabitants, the cost of such improvements, other than that paid by federal and other funds, to be assessed against the property abutting thereon, and being

WHEREAS, said improvements have been made, the cost thereof determined, special assessments levied, notice given of such special assessments for more than thirty days and the liability of the Board of County Commissioners of the County of Douglas, State of Kansas, and for which amount, bonds are to be issued, determined to be the sum of \$15,000.00.

BE IT RESOLVED that The Board of County Commissioners of the County of Douglas, State of Kansas, issue and sell 30 coupon bonds of said County of Douglas, and State of Kansas. That the same be dated August 1, 1938; that the denomination of each be \$500.00; that they be numbered 1 to 30 inclusive; that interest be paid on said bonds semi-annually at the rate of 1 3/4 per cent per annum; and that the maturity date of such bonds be as follows:

ROAD IMPROVEMENT BOND .

KNOW ALL MEN BY THESE PRESENTS, That the County of Douglas in the State of Kansas, is indebted to and hereby promises to pay the bearer the sum of

FIVE HUNDRED DOLLARS

in lawful money of the United States of America, on the First day of August, 1939, with interest thereon at The rate of one and three-fourths (1 3/4) per cent per annum, payable semi-annually on the First day of Fobruary and the First day of August of each year until the principal sum shall be paid, upon presentation and surrender of the proper interest coupons, hereto attached, bearing the facsimile signatures of the Chairman of the Board of County Commissioners and the County Cle Clerk of said county, as they severally become due.

Both principal and interest of these bonds are payable at the office of the State Treasurer of the State of Kansas in the City of Topeka, Kansas.

The said County of Douglas is hereby held and firmly bound by these presents and the full faith, credit and resources of said Douglas County, Kansas are hereby pledged for the prompt payment of said principal and interest at maturity.

This bond is one of a series of thirty (30) bonds of like denomination, date, and tenor, except as to dates of maturity, aggregating the principal sum of Fifteen Thousand Dollars (\$15,000.00), the same being issued by said County of Douglas to provide funds for the payment of that part of the cost of themaking of certain improvements in the paving, curbing, grading, and drainage of Emery Road, West Hills Parkway, Stratford Road, and University Drive which is chargeable and apportioned to the parcels and tracts of land abutting thereon, and said bonds are issued under and by virtue of and in full compliance with the provisions,
