## RESOLUTION

CONCERNING TAX LEVIES FOR THE YEAR 1939 TO PROVIDE FUNDS FOR COUNTY PURPOSES IN ACCORD WITH THE BUDGETED EXPENDITURES FOR THE FISCAL YEAR ENDING DECEMBER 31, 1939.

WHEREAS, on this 1st day of September, 1938, the same being a regular meeting of the Board of County Commissioners, Douglas County, Kansas, there came on for consideration of said Board, the matter of certifying levies determined as necessary to raise by ad valorem taxation amounts as set up in the county's budget for the year 1939, and

WHEREAS, at a public hearing for said county budget, on the 15th day of August, 1938, it was so adopted.

NOW, THEREFORE, BE IT RESOLVED by the Board of County Commissioners, Douglas County, Kansas, that the amounts to be expended for the ensuing year, for the various funds, are as follows:
