Due to the fact that the family has no property and cannot pay the costs, the Superintendent of the hospital asked for the Board of County Commissioner's agreement if this man is to remain at the hospital. The agreement calls for the county to pay the costs of committment, and court costs, if, at any time, the patient is taken to court for judgment. The Board unanimously agreed to said obligation, and accordingly, signed the proper papers.

No further business appearing, the Board adjourned to meet again Friday, September 23, 1938, at 9:30 A. M.

In regular adjourned session, this day, the Board of County Commissioners of Douglas County, met in the regular meeting rooms of said Board with all members and the County Clerk present.

Due to the pressing work in his office, Clifford Harding, District Supervisor of FSA, reported to the Commissioners that he had hired a stenographer in his office without the consent of the Board, said stenographer working since the 15th of this month. He, also, informed the Board that Franklin County is going to hire two girs1 for the office, and Topeka is sending two assistants in. He is asking that Douglas County pay the wages of one girl and other incidental expenses. The Board, recognizing the need of additional help in the office agreed to pay the wages of the stenographer recently hired by Harding. Sald stenographer, Eucy Spalding, to be paid the wage of \$12.50 per week. As per appointment, W. R. Taylor and O. Q. Claflin, Trustees for the K. C., K. V. and Western Railway, met with the Board, seeking a compromise on the taxes levied against said railroad by Douglas County. Also, present, at this time, was Charles A. Springer, County Attorney and Mildred LeSuer, County Auditor.

Under their plan of Reorganization, Claflin stated that only \$2500 is set up for the payment of taxes, said amount to cover the taxes delinquent in Wyandotte, Leavenworth and Douglas Counties. On this basis they offered the compromise of $12\frac{1}{25}$ on all taxes delinquent in Douglas County and also the current year's tax which is due the lst of November. It was their argument presented that unless they could compromise as per their offer, the only alternative was to "junk" the railroad. The total amount of taxes delinquent is in the amount of $-\frac{1}{250}$.

Although, a long discussion was gone into, no official action, was taken this day. A meeting was set for Wednesday October 5, at the hour of 10 o'clock A. M.

Geo. Bigsby, Salesman for the Thacher Supply, Inc., appeared before the Board presenting his offer on a large card file for the office of the County Auditor. The Board informed Mr. Bigsby that it thought it wise to call for bids on said file due to the fact that the cost of the file exceeds the amount of \$50.00; and since it has been the policy of the Board to secure bids for purchases over this amount.
