A petition from Will C. Hoad, for Order cancelling taxes erroneously assessed, was presented to the Board by C. C. Stewart, Attorney. However, no action was taken on the matter this day.

Earl T. Black moved that the following orders be made for the refund of taxes. James F. Brass seconded the motion. On vote, all voted unanimously.

Order No. 63.

To cancel taxes for the year 1933 in the amount of \$10.91, charged in the name of Hilma Anderson on the property as follows:

Beginning twenty-three (23) rods and seven feet (7') east from the Southwest corner of the Southeast Quarter of Section Thirty-four (34) Township Eleven (11), Range Eighteen (18); thence East twelve (12) rods and four feet (4'); thence north eight rods (8) and Nine (9) feet; thence west twelve (12) rods and four (4) feet; thence south eight (8) rods and nine (9) feet to place of beginning, in the City of Leocompton.

On November 10, 1933, the above property became the property of the First Church of the Deaf, Topeka, Kansas. Note the accompanying order from the State Tax Commission under date of January 19, 1934, covering the cancellation of the taxes for the year 1933. (See file)

These items were entered for correction in October and November, 1937, but the formal Order was not issued due to an oversight.

Order No. 65

To amend and correct Order #55, made by action of this Board at its meeting on January 26, 1938, cancelling taxes for 1936 in the amount of \$1115.17 and for 1937 in the amount of \$112.92. The amounts above set forth are incorrect and the Order for cancellation should be as follows:

To cancel 1936 tax in the amount of \$83.37 on a valuation of \$3000.00, and penalty on said tax in the amount of \$3.91 to make a total cancellation on 1936 Tax Sale No. 313 of \$87.28.

To cancel 1937 tax in the amount of \$79.35 on a valuation of \$3000.00.

The above tax was assessed against the following description: Begin NW cor. of NW 1/4, S 12 273/1000 ch., E 8 60/100 ch., S 6 977/1000 ch., again S 214' to center of Warrent St. extended W along center 510', N to N line of NW 1/4, W 15 32/100 ch. to beginning, less tract to White and 252/1000 a. Rt. of Wy. (21 248/1000 a.) in 36-12-19. The dwelling on this property was destroyed by fire on April 2, 1935 and its valuation of \$3000.00 was never removed from the tax rolls.
