Louk, three disinterested householders of Douglas County, Kansas, be and are hereby appointed to appraise the lands abutting on said Street in Douglas County, Kansas, and outside the City of Lawrence and make the report of their appraisal to this Board, said appraisal to be made without regard to the improvements thereon.
