November 12, 1938.

In accordance with the law as set out in Chapter 25-217, General Statutes of Kansas, 1935, the Board of County Commissioners met at 10:00 A. M. in the rooms of said Board to sit as the Board of Canvassers, there being present all members and the County Clerk.

The Board entered at once on the canvassing of poll books as returned by the Clerks of Election, for the General Election held November 8, 1938. The few discrepancies discovered were corrected as per poll book of said election.

The Board adjourned as a Board of Canvassers to meet again Tuesday, November 15, for the purpose of canvassing In-State, Out-of-County ballots.

Convening as the Board of County Commissioners, said Board gave consideration to several matters coming to its attention.

The following Cancellation Order of the Board of County Commissioners No. 67 was passed:

By motion, properly seconded and voted, the Board of County Commissioners allowed the claim presented by the County Clerk for the election boards on duty for the General Election held on the 8th of November.

Charles E. Banning appeared before the Board for a discussion on various matters of business.

No further business coming before the Commissioners, the Board adjourned to meet Saturday, November 19, in the regular meeting rooms of said Board.
