	Appearing before the Board, came Charles E. Banning and Mrs. Banning to present quotations for wall paper to be used for improving the Sheriff's dwelling. The quotations, as submitted, were gone over thoroughly by the Board. The Commissioners asked that further bids be secured before decision was made on the matter.
	A delegation from the Lawrence Women's Club, consisting of ten members met with the Board and the County Attorney for the purpose of discussing a compromise for the delinquent taxes due against the club; also expressing the desire to have the valuation on the property in question reduced.
	The merits of the club were brought out by each member present, who voiced her opinion of same. It was asked that all delinquent taxes and also the 1938 taxes be abated, as it was quite impossible for the club to raise the money for payment of same. They asked that the valuation be reduced to the sum of \$5000, which is the purchase price of the property. Although, considerable discussion was gone into on this matter, no answer could be made by the Board at this time.
	The assessors, Willard Brown, A. J. Farnell and Roy Martin, conferred with the Board on the assessment they placed on the Lawrence Women's Club.
	The matter of releasing some water from the Lone Star Lake was brought to the attention of the Board. It was moved by Commissioner Brass and seconded by Commissioner Black that due to the request of the citizens of Lone Star and also of the Sportsmen's Club that some water be released from the Lone Star Lake to save the fish in said lake, and for the purpose of supplying stock water. It was also moved that the Engineering Department be authorized to attend to same. The motion was put to vote by the Chairman, all Commissioners voting "aye".
