The County Attorney came before the Board with E. E. Morris of the Dunne-Israel Investment Company in regard to the bond issue for Barker Avenue. Considerable discussion was given to this matter, and after so doing, James F. Brass moved that the Commissioners accept the offer presented by Mr. Morris and approve the following contract. Earl T. Black seconded the motion. On vote, all Commissioners voted "Aye".
