WE WILL PAY par and accrued interest, bonds maturing Jan. 1, 1940 to Jan. 1, 1944 inclusive, to be $1\frac{1}{2}\%$ coupon. Balance Jan 1, 1945 to Jan 1, 1949 inclusive to be 2% coupon; we to pay cost of printing and legal opinion, subject to delivery in three weeks; after that at our option.

This offer is submitted for immediate acceptance and with the understanding that prior to delivery of the above bonds, you are to furnish us with a complete certified copy of the transcript of proceedings had incident to and in the issuance of the bonds that will evidence the legality of same to the satisfaction of our attorney, and to take any further steps that may be required by our attorney to make the bonds fully legal.

We herewith hand you our certified check for \$210.00 as evidence of our good faith in complying with the terms and conditions of this bid, which is to apply as part payment of said bonds when the legality of same has been approved by our attorney, and to be forfeited as liquidated damages should we fail or refuse to take up said bonds as above provided. Said check is to be returned to us if this bid is not accepted, or if our attorneys should decline to approve the legality of this issue. In the event the State School Fund Commission shall exercise its option to purchase these bonds, it is understood that you will allow us the sum of \$_____ to cover our expense in preparing and directing the bond proceedings.

Once more, Mrs. Pontius and Mrs. Nelson, representing the Lawrence Women's Club, appeared before the Board in regard to the abatement of taxes now due and those delinquent against the property of said club. The object of their visit at this time was to know that if they were able to get the abatement of taxes by legislative action, if the Board would lower the assessed valuation on the property. The Board informed the delegation that it would be glad to give them consideration on this matter at the proper time when the Commissioners sit as the Board of Equalization.

Clifford Harding of the Farm Security Office came before the Board requesting that Douglas County give \$40.00 per month for additional help in his office. He stated that Franklin County has agreed to pay \$60.00 per month for salary and to pay about half the maximum mileage which is \$20.00 per month, making a total sum of \$80.00. Mr. Harding informed the Board that such additional help would terminate no later than March 1, 1939.

It was moved by Earl T. Black that the Board authorize the payment of \$40.00 a month for additional help in the Farm Security Administration office, beginning as of December 19, 1938 and extending through to March 1, 1939; and in additional transportation cost not to exceed \$20.00 per month, making a total of \$60.00 a month. A second was made by James F. Brass. On vote, called by Chris Schaafe, Chairman, the motion carried by unanimous vote.

The County Engineer and Fred Martin of the Martin Tractor Company discussed the purchase of a shovel for the county, with the Board of County Commissioners.

The following Commissioner Order was allowed:

No. 33

To cancel 1938 Real Estate Tax in the amount of \$18.93 charged to the Kansas Electric Power Company, covering 14.829 acres in Wakarusa Township, Section 14-12-19. This tract of land is the portion acquired from Ben Kowing by the Kansas Electric Power Company for power, house purposes; and was assessed in the corporate returns by the State Tax Commission for 1938. Was assessed also on regular tax rolls.

Duplicate assessment.

14.829 acre tract - Valuation \$1245.00 - School District No. 53. Rate of \$14.75 Tax \$18.93 to be cancelled.
