T. F. Yost, Deal Six and Asa Colman met with the Board of County Commissioners in the regular meeting rooms of said Board. The bindweed program for the year 1939 was gone into by all present. It was suggested by Yost that Township programs be set up with a field man for each township to supervise the eradication of bindweed in his respective township, in addition to the County Bindweed Supervisor.

Joseph Robinson, Kansas City, Mo. appeared before the Board in regard to the valuation placed on his farm located in Palmyra Township, Douglas County, contending that said valuation is far excessive. Although, the matter was considered, no action was taken by the Board.

Mrs. W. O. Nelson came before the Commissioners to discuss several matters of business, among them, the appointment of the County Health Officer. The Board informed Mrs. Nelson that said appointment will be made after the first of the year, when the Board of County Commissioners re-organizes.

Again, Lutie Kern appeared before the Board in reference to the valuation on his property, located on Kentucky Street, Lawrence, Kansas.

The Board adjourned.
