

COMMISSIONER'S RECORD M

WHEREAS, said improvements have been made and that part of the total costs to be assessed against the abutting property has been determined and special assessments made therefor; that notice by thirty days publication in the Lawrence Daily Journal World, as provided by law, has been given to such property owners of such special assessments and thirty days have passed and certain of said assessments are not yet paid, and

WHEREAS, temporary notes have been heretofore issued for the purpose of paying the cost of such improvements as payments became due, such temporary notes other than the part paid from funds allowed by the United States and from such assessments collected, to be paid by the issuance of bonds of Douglas County, Kansas, and

WHEREAS, the amount for which the Board of County Commissioners of the County of Douglas and State of Kansas is liable for the above mentioned improvements and the amount for which bonds are to be issued to cover such liability have been determined to be the sum of Nine Thousand and Two Hundred Dollars (\$9,200).

BE IT RESOLVED that the Board of County Commissioners of the County of Douglas and State of Kansas, issue and sell coupon bonds of the County of Douglas and State of Kansas, in said amount of Nine Thousand and Two Hundred Dollars (\$9,200). That said bonds be dated the first day of January, 1939; that interest be paid semi-annually thereon; and that the denomination of such bonds, the maturity dates, and the rates of interest be as follows:

That the interest to be due on said bonds shall be evidenced by coupons, attached to and numbered to correspond to the number of the bonds to which they belong; that said coupons shall bear the lithographed facsimile signature of the Chairman of the Board of County Commissioners of the County of Douglas and State of Kansas and of the County Clerk of said County, which signatures said officials hereby adopt as their respective signatures for such coupons. That said bonds shall be executed on behalf of said County by the Chairman of the Board and attested by the County Clerk and have the seal of Douglas County, Kansas, affixed thereto and shall be in the form, except as to interest and maturity, substantially as follows:

ROAD IMPROVEMENT BOND

KNOW ALL MEN BY THESE PRESENTS, That the County of Douglas in the State of Kansas, is indebted to and hereby promises to pay the bearer the sum of

ONE THOUSAND DOLLARS

in lawful money of the United States of America, on the First day of January, 1941, with interest thereon at the rate of one and one-half (1 1/2%) per annum, payable semi-annually on the First day of July and the First day of January of each year until the principal sum shall be paid, upon presentation and surrender of the proper interest coupons, hereto attached, bearing the facsimile signatures of the Chairman of the Board of County Commissioners and the County Clerk of said County, as they severally become due.

Both principal and interest of these bonds are payable at the office of the State Treasurer of the State of Kansas, in the City of Topeka, Kansas.

The said County of Douglas is hereby held and firmly bound by these presents and the full faith, credit, and resources of said Douglas County, Kansas, are, hereby, pledged for the prompt payment of said principal and interest at maturity.

This bond is one of a series of nine (9) bonds of like denomination, date and tenor, except one bond, number one (1) which is in the sum of Twelve Hundred Dollars (\$1,200.00) and except as to dates of maturity and rates of interest, aggregating the principal sum of Nine Thousand and Two Hundred Dollars (\$9,200.00), the same being issued by the said County of Douglas to provide funds for the payment of that part of the cost of the grading, paving, curbing and guttering, and otherwise improving of roads in said County known as Barker Avenue from 15th Street to the North line of Maple Lawn Addition; Barker Avenue from the Center of 19th Street to the South Line of 20th Street and 19th Street from the East Line of Barker Avenue to the West Line of Larnard Avenue which is chargeable and apportioned to the parcels and tracts of lands abutting thereon, and said bonds are issued under and by virtue of and in full compliance with the provisions, restrictions, and limitations of the Constitution and Laws of the State of Kansas, relating to the paving and otherwise improving of roads which form a boundary between a City of the second class and outlying tracts and parcels of lands adjoining any such City
