<u>RESOLUTION</u>

WHEREAS, during the year 1934, Mary F. Priest signed an easement on the SWE of Section 22, T 12 S, R 18 E, for the purpose of constructing a water reservoir, labor for same to be supplied by the Kansas Emergency Relief Committee.

WHEREAS, the general public were permitted to have access to said water reservoir by authority from the County Commissioners under a resolution declaring a drouth emergency, when such exists.

WHEREAS, on the 15th day of August, 1938, the County Commissioners did pass an emergency drouth resolution permitting the public to get, and take away water from the said Mary F. Priest pond.

WHEREAS, the supply of water in said pond has been so depleted by continued drouth, and public use, that there is no longer sufficient water to aupply the public.

THEREFORE WE/rescind our emergency drouth resolution relative to the Mary F. Priest pond, issued under date of August 15, 1938, and declare same closed for public use.
