May 31, 1939.

All members of the Board of County Commissioners met in special session this day, said meeting having been called by the Chairman as said Board, for the purpose of discussing the Welfare budget.

Present, also, during this meeting were: Mildred D. Watson, County Welfare Director, Leon G. Abele, Supervisor of Business and Finance and Mildred LeSuer, County Budget Director.

It was the opinion of the Board to cut the budget as much as possible without the danger of exceeding same for the ensuing year. After some discussion on it, the Board directed Mildred LeSuer and Leon Abele to figure the budget on two different basis and then, submit it, again, for discussion.

The feasibility of establishing a work project at the Lone Star Park on which relief clients could work, was considered. This project would be set up for employable men who are unable to secure jobs. No action taken on this matter this day.

At the hour of 1:30, John G. Stutz, also, met with the Board to enter into the discussion of Douglas County Welfare Budget. Mr. Stutz said that the units used in making up the budget are too high, and he suggested that the Board use the unit that it thought best taken from past exporience. The budget was gone over in detail and considerable discussion was given to same.

Commissioner Jas. F. Brass stated that he was strictly in favor of the lowest possible budget and desired to keep the levy as low as possible. He thought it best to make the budget no more than it was deemed necessary, and then if it was found later on in the year that sufficient funds would not cover actual expenditures, it would be possible to issue bonds to take care of the deficiency.

Ad journment was taken.
