Claims against the county for salaries, wages, materials etc., were passed upon and allowed as recorded on the Allowance Record under this date.

Clifton Ramsey met with the Commissioners for a short discussion on the Lake matter. He assured the Board that Mr. Veatch was ready to sign a deed just as soon as he had assurance from the County Board as to when the fence around his property would be erected.

The Welfare Budget was approved and signed by the Chairman of the Board. The levy set up was 2.5058 for the year 1940.

Mr. A. F. Luder and a Mr. Davis, Representatives of the Industrial Machinery Company were present in an effort to interest the county in the purchase of a weed mower. No purchase was made, at this time.

Adjournment was taken until Monday June 5.

In regular adjourned session, all members of the Board of County Commissioners and the County Clerk convened in the regular meeting rooms of said Board.

The Board talked to the County Treasurer on the wages for the office help in the Treasurer's office.

A report was made to the Board by Clifford Harding, Supervisor of the Farm Security Office, of the loans made in the County of Douglas by said office. Because of the number of loans being made and the need for the help of the assistant he had been using, he asked if the Board would considering retaining the said assistant, at perhaps, a lower salary than he had been receiving. The Board wished to have a little time to think this over before giving an answer.

Further claims against the county for wages, materials and supplies were by the proper motion, second and vote, allowed this day as recorded on the Allowance Record.

A short conference was held with Sheriff Charles Banning. The sheriff reported that the boiler for the jail was in very bad shape and needed considerable repair.

By motion, the Board adjourned to meet Tuesday, June 6, at which time the Board would sit, also, as a Board of Equalization.

Trustee of Marion Township, John Elm, again, came before the Board in regard to action taken on the John Brecheisen Road. No decision has been taken.

Floyd Kalb met with the Board to discuss the appointment of Trustee for Palmyra Township. Mr. Kalb did not apply for the position, but discussed the qualifications of others who had applied.

The application of Hannah Belle Roberts for admittance to the Sanatorium for T. B. at Norton, was presented to the Board. After carefully considering same, Chris Schaake moved that the Board accept the application for Hannah Belle Roberts for her admittance to the T-B. Sanatorium as a county patient. Jas. F. Brass seconded the motion. On vote, all Commissioners voted "Aye".

On this day the Board considered the appointment for Trustee of Palmyra Township to fill the vacancy left by the resignation of C. A. Lane. The applications of several applicants were on the table for discussion. Action was taken in the following motion: It was moved by Chris Schaake that the Board appoint A. D. Van Tries to the position of Trustee of Palmyra Township, to fill the vacancy left by the former Trustee. Jas. F. Brass seconded the motion. On vote, called by Chairman Black all commissioners voted unanimously for the motion.

Fred Martin from the Martin Tractor Company appeared before the Board for the purpose of interesting said Board in the purchase of a mowing machine.

The Board adjourned to reconvene as a Board of Equalization.

The Board immediately adjourned for a tour of viewing certain properties that had come to its attention during the ten day period for the hearing of complaints.

Reconvening, again, at the courthouse, the Board went into discussion on certain properties, then adjourned to meet July 7, for the final meeting of the Board of Equalization this year of 1939.
