September 19, 1939.

In special session, this day, all members of the Board of County Commissioners, namely: Earl T. Black, Chairman, Jas. F. Brass and Chris Schaaque, Commissioners and T. R. Gerhart, County Clerk, met in the regular meeting rooms of said Board.

The purpose of this meeting was to entertain Arthur F. Lindbergh, Representative from the National Park Service, Clifton Ramsey, Ernest Boyce, Harry Nevin, Arthur Fritzel, Frank MacDonald and E. E. Trueblood, County Engineer, on the matter of obtaining aid from the National Park Service as to improvements, yet, to be done at the Lone Star Park.

There are three essential things, the county must abide by in order that its application may be considered. First there is maintenance. There must be some proof given that the county is not only willing but will maintain the Lone Star Park. In the application, there must be proof as to the levy for this purpose (citation of law etc.). The CCC camp is to be sponsored by the county, with the National Park Service supervising the work. The purpose of the maintenance requirement is to show the county's ability for this.

Second is participation. A statement on the amount of money that the county can furnish in the way of materials, is required. This is asked so that there may be sufficient money for this purpose to complete the work, in case the desired improvements exceed the amount that can be furnished by the Park Service. Mr. Lindbergh stated that each camp is allowed a budget of about \$2300 per month, out of which \$500.00 is budgeted for materials. This amounts to \$6000.00 per year. It was thought that \$4000.00 or \$5000.00 per year would be an approximate amount to be contributed by the county.

Third is the Master Plan, which is a long time plan of the entire area, to be made by a competent United States architect cooperating with the County Engineer. The architect would have to be employed by the county, as the Park Service cannot afford to send out men for this purpose. This is a very important requirement, as the Service must have this plan in order to determine just what has to be done in the way of improvements for the Park.

Mr. Lindbergh stated that approval of Douglas County's application would depend upon the three foregoing requirements. Said application should be submitted sometime in December, 1939, in order to be considered for the new period beginning in April, 1940.

It was suggested that the county make application to Mr. French, New Federal Bldg., Omaha, Nebraska, for retention of the buildings now at the Park, if said county were contemplating on using said buildings.

No further business appearing, the Board adjourned.
