Gene Glahn from the Manley Insurance Agency was in for a short discussion on insurance for the county cars.

For the auditing of county records for the period from January 1, 1939 to December 31, 1939, bids were opened this day:

Jas. F. Brass moved that the contract for auditing county records for the period from January 1, 1939 to December 31, 1939, be awarded to the J. E. Caton Company at their bid price of \$800.00, lump sum. Chris Schaake seconded the motion. On vote, all Commissioners voted "Aye".

Mr. H. V. Stone, Auctioncer, who had previously presented a bid to the Board for the auctioneering of delinquent properties at the Judicial Tax Sale, but did not state a specified rate, discussed his bid with the Board this day. He verbally stated that his rate would be $2\frac{1}{2}$ on the percentage basis.

The Eudora Township Board asked the county to permit them to come under the County Blanket Project for about four miles road improvement in said township, which the County Board agreed to do. The County Engineer, present at this time, was directed to prepare the proper papers.

Claims against the county for materials and supplies and claims from the Welfare Department were minutely inspected and allowed by proper motion as recorded on the Allowance Record in the office of the county clerk.

Nothing definite could be done this day, although the Board is taking these requests under advisement. It was suggested by Wr. Veatch that the county have a transformer placed at the well so as to have electric power at the park.

Chris Schaake moved that the county authorize the power company to place a hook-up at the well for electric power services, for the Lone Star Park. Jas. F. Brass seconded the motion. On vote, all Commissioners voted "Aye".

(Representative from power company stated that the temporary minimum would be \$5.00.)

Mrs. B. Z. Stephenson made application to the Board for the position of Superintendent of Schools if the present Superintendent should secure a Post Office position. She was directed to place a written application on file with the County Clerk.

For another discussion on insurance for the county cars came Gene Glahn, Representative of the Manley Insurance Agency.
