October 25, 1939.

In regular adjourned session, all members of the Board of County Commissioners, met in the regular meeting rooms at the courthouse to attend to regular county business.

With the County Attorney, County Treasurer, Sheriff and Ernest Kloor, abstractor, the Board set up several regulations pertaining to the Judicial Tax Sale to be held Saturday, October 28 and from then on until completion of the sale of the first group of properties (298 pieces.).

1. Bankable checks will be accepted.
  2. Sheriff's deputy will act as cashier and money will be paid at the Sheriff's office.
  3. Printed forms will be used for record of sales. (Board authorized the County Treasurer to have same printed.)
  4. Roy Flory, County Treasurer will be Clerk of Sale.
  5. Payments on morning sales must be made by 2 P. M. of the same day.  
Payments on afternoon sales must be made by 9 A. M. of the following day.
  6. Sale will be held at the front door of the courthouse unless bad weather necessitates removal to the courtroom.
  7. Property will be sold to the highest and best bidder.
- The responsibility of securing the seats and auctioneer platform was given to the Sheriff.

In regard to hiring extra help for police duty at the Cornhusking contest to be held on the 3rd of November, the Board gave the Sheriff authority to contract for the services of ten (10) men from the Burns Company, Kansas City, at the price of \$10.00 each, the county to pay the transportation to and from Lawrence. These men are officers of wide experience in regard to Underworld activities.

No action was taken this day on the acceptance of a bid.

A quotation of \$32.50 for the repairing of the roof on the Jail was made by Mr. C. Martin from the Seiler Roofing Company. He, also, quoted the prices of \$138.00 and \$153.00 for a new roof--difference in prices due to the layers placed for a new roof. (2 layers for \$138.00 and 3 layers for \$153.00.)

It was moved by Chris Schaae that the Board accept the bid of the Seiler Roofing Company for the repairing of the roof of the Jail for the price of \$32.50. Jas. F. Brass seconded the motion. On vote, all Commissioners voted "Aye".

Probate Judge Frank R. Gray discussed with the Commissioners the welfare of the Wilson twins, William Ray and Robert Jay. It was finally decided that the county should pay the amount of \$3.00 each per month, therefore Chris Schaae moved that the County pay to the Lawrence National Bank, direct, as Guardian, the amount of \$3.00 each per month for William Ray and Robert Jay Wilson, Minors. Jas. F. Brass seconded the motion. On vote, called by Chairman Earl T. Black, all Commissioners voted in the affirmative.
