The Douglas County Board of Commissioners and the County Clerk met in adjourned regular session in the regular meeting rooms of said Board.

H. D. Thomas, Auctioneer, made a personal application for the job of auctioning properties for the second group of the Judicial Tax Sale; his rate is 1%, the same as previously. The Board unanimously approved his being employed for such work at the rate of 1%.

The application of Francis D. Potts for admittance to the State ^{Sanitarium} (Sanatorium) for T.B. was presented to the Board for action. Jas. F. Brass moved that the said application of said patient be accepted; and that Francis D. Potts be admitted to the State Sanatorium for T.B. as a county patient, with the understanding that William Potts, son, will reimburse the county the sum of \$1.00 per day, actual cost for the county for the care and treatment of said patient. Chris Schanke seconded the motion. On vote, motion carried unanimously.

At the hour of 9 o'clock A. M., all members of the Board of County Commissioners and the County Clerk met in regular adjourned session.

Again, a Lake View delegation, consisting of C. A. Karlan, Dr. Clement Smith, George Hedrick, Wesley Brune, Al Green and Mr. Plummer, met with the Board and the County Engineer for another discussion on the construction of a ditch from Baldwin Creek to Lake View for the purpose of providing water for said lake which is now dry. A tentative plan was set up whereby the county would rent the power shovel to the club for the digging of the ditch--the county, itself will be responsible for the construction of a bridge, which will be necessary once the ditch is made. The Board wished to draw up a definite plan before taking any formal action. Therefore, the meeting adjourned until some future date.

It was the unanimous approval of the Board that C. F. Wilson be allowed to pay the actual amount of tax minus the penalties and interest, which is now a tax judgment on the Judgment Docket in the office of the Clerk of the Court.

Again, Mr. Moore, Salesman for the Williams-Roberts Motor Company, appeared before the Board in an effort to sell to the county a 95 H.P. Ford for the use of the Sheriff's Department. No action taken. This matter was, also, discussed by the Board with the Sheriff, Chas. E. Earning.
