In regular adjourned session this day, all members of the Board of County Commissioners and the County Clerk met in the regular meeting rooms of said Board.

The following Cancellation Orders were passed by the Board:

No. 170: CANCEL 1939 Dog Tax of \$1.00, erroneously assessed to Mrs. Harry Treworgy, 701 Maine, Lawrence.

Jesse Deay requested if the county could furnish the pipe in order that he may secure water from the government well on his property, with which to water his stock. At Mr. Deay's request, the Board consented to Alva Hodge's helping in the fitting of the pipe etc.

In the afternoon, the Board adjourned to view a road in Lecompton Township, petitioned by R. E. Schroyer et al for the vacation of same; said road being described as follows:

Beginning at the  $\frac{1}{4}$  corner on east line of Sec. 14-12-18; thence west one mile through Sec. 14-12-18, and terminating at the  $\frac{1}{4}$  corner on West line of said Sec. 14. And in lieu of this vacation, it was petitioned to widen from 40 feet to 60 feet, one mile of old road and improve same, beginning at the SE corner of Sec. 14-12-18; thence west one mile, and terminating at the SW corner of said Sec. 14, which point is in an all weather surfaced road.
