The Board informed Mr. Flory that this matter was in his hands, but it thought the feasible plan would be to designate more out of the county depositories, since it is apparent banks in this county will not furnish more security for public funds.

Mr. A. F. Luder, Representative of the Industrial Machinery Company, and the County Engineer, E. E. Trueblood, met with the Commissioners, regarding the purchase of a mowing machine for the Engineering Department. The machine recommended by Mr. Luder is a 6 cyl. 60 H.P. machine, manufactured by the Toro Manufacturing Company. Weight of said machine is 2300 pounds. Mr. Luder quoted the net price of \$1,078.50 delivered at Lawrence.

On the matter of purchasing a road maintainer and a mower there appeared, also, Fred Martin of the Martin Tractor Company. On checking the budget balances in the Road Fund, it was discovered that there was only sufficient money to purchase one machine, and because, at this time of the year, there is more need for the patrol, it was recommended by the County Engineer that this be given preference. The total cost of the patrol with cab is \$6,111.00 with an offer of \$1900 for the old maintainer which has been of five year's use.

It was moved by Chris Schaake that the county purchase one (1) No. 12 auto Patrol with 6 It was moved by thris Schake that the county purchase one (1) No. 14 auto Patroi with 6 cylinder diesel motor, 12 foot blade and inclosed cab at the price of \$4,211.00, including a trade-in allowance on one (1) old No. 11 Auto Patrol of \$1,900.00. Jas. F. Brass seconded the motion. On vote, called by Chairman Earl T. Black, all Commissioners voted in the affirmative. The County Engineer was authorized to draw up the purchase order for the Martin Tractor Company.

The Board discussed the purchase of a new car for the Sheriff's Department with Lathrop Read, Jr. Undersheriff.

To discuss some matters pertaining to the Lone Star Park, there appeared a delegation, consisting of Edwin F. Abels, Clifton Ramsey, Ernest Boyce, Art Weaver and Dolph Simons. The main purpose of this meeting was to discuss the possibility of securing some camp, either the Mational Park Service or the Soil Conservation camp, whereby improvements at the park may be completed.
