Claims against the county for salaries, wages and materials, were by proper motion, second and vote, allowed by the Board in amounts as recorded on the Budget Register in the office of the County Clerk.

Harry Frazee, Attorney went into a general discussion of the K. C. K. V. and Western RR case now in the Circuit Court of Appeals.

A. A. Marshall, applicant for a beer license, presented to the Board three written consents to the issuance of said license, signed by the three members of the Wakarusa Township Board, although the ten days of time for which a township board is allowed to make a written objection, has not expired. The Board wished to discuss this matter with the county attorney before taking action.

Minutes for the month of June, 1938, were read by the Commissioners, and after completion, by proper motion, second and vote, approved as read.

Adjournment was taken to meet again Wednesday, January 3, 1940.

All members of the Board of County Commissioners and the County Clerk convened this day in adjourned regular session.

Upon the strength of written consent of the three members of the Wakarusa Township Board, the County Attorney gave his approval to the issuance of a beer license to A. A. Marshall. Whereupon, the following resolution was passed by the County Board:

R E S O L U T I O N

WHEREAS, on the 3rd day of January, 1940, the same being a regular adjourned meeting of the Board of County Commissioners, the application of said Board, and

WHEREAS, the Board does find that the said A. A. Marshall, is in all ways qualified under the law to sell cereal malt beverages for consumption on the premises, and

WHEREAS, the Board further finds that a due and legal notice has been given to the Wakarusa Township Board, and that written notices consenting to the issuance of said license, have been filed by the Wakarusa Township Board.

NOW, THEREFORE, BE IT RESOLVED that the applicant A. A. Marshall be granted a license to sell cereal malt beverages for consumption on premises at the place so described in application.

BE IT FURTHER RESOLVED that T. R. Gerhart, County Clerk of Douglas County, be, and he is hereby directed to issue said license.

With the County Clerk, Assessors Oren Owen and Harry Gregg, the Board discussed the Personal Property assessment of Terry Gaskill, on furniture located at 1113 Pa. St. and on household goods at 321 Missouri. It is the complaint of Terry Gaskill that this furniture at 1113 Pa., which he uses in a rented house, was included in the assessment that was taken at his home at 321 Mo.; and that the amount of \$40.00 was far excessive for same. Oren Owen, Assessor, reported that he took the assessment at 1113 Pa. and that he listed the furniture, that was shown to him by the tenant to be the property of Mr. Gaskill, at what he thought was a fair value of \$40.00. Harry Gregg, Assessor, stated that he took the assessment at Mr. Gaskill's home, but did not include in this assessment the furniture at 1113 Pa., nor any other personal property belonging to Mr. Gaskill that may be located elsewhere. Mr. Gaskill, also, attended this hearing and offered to sell this furniture to the Board at the price of \$6.00 plus cancellation of the \$1.50 tax on the property at 1113 Pa. He claims that he was of the opinion that this furniture was included in his assessment at his home.

The Board thought it best to take the above matter under advisement.

The County Engineer spoke to the Commissioners on some road matters.

The Board adjourned to meet Saturday, January 6, 1940.
