The following is a resolution, passed this day, in regard to condemnation proceedings against land owned by Elsie Dershem for the obtaining of additional land for the improvement, widening and straightening of Road No. 332, near the City of Baldwin:

RESOLUTI ON

WHEREAS, the matter of obtaining additional land for the improvement, widening and straightening a certain road, No. 332, near the City of Baldwin, in Douglas County, came on for consideration.

AND WHEREAS it appears from the report and survey of the County Engineer, E. E. Trueblood, that it is necessary for the improvement of said road to alter the said road and make a change in the location of the same and widen the same from forth feet to fifty feet, and in making said alteration, additional land must be obtained for said purpose, said land being described as follows, to-wit:

Beginning at a point 33 feet East, and 20 feet South of the NW corner of Section 14-T15S-R2OE, th East 817 feet, thence South 10 feet, thence West 817 feet, thence North 105 erects, the past of rest, there's south 10 fout, there's most of rest, and 20 feet 10 feet to point of beginning. Also, begin at a point 1300 feet East, and 20 feet South of the Northwest corner of said Section 14, thence East parallel to North line of said Section 14, 680 feet, thence South 10 feet, thence West 680 feet, thence North 10 feet to point of beginning.
