John Stephens, Assistant Engineer spoke to the Board in regard to using the county snow plow on township roads. It was agreeable with the Board to help the townships whenever possible in getting their roads clear.

Mrs. Barbara Kennedy inquired if the Board would be desirous of purchasing land belonging to her, namely 40 acres in Section 12-14-19, Willow Springs Township; or of not the land perhaps they would be interested in purchasing the wood off the property. For the land she thought she should receive the assessed valuation, at least, which she quoted at \$550.00. The Board assured her that it would give some consideration to the matter.

Everett Bond interviewed the Board in regard to securing a position at the Lone Star Lake. The Board has reached no decision on this, yet.

The Board adjourned to meet Wednesday, January 31, 1940.

February 1, 1940.

For the first meeting of the month, all members of the Board of County Commissioners and the County Clerk met in the regular meeting rooms of said Board.

The regular claims for salaries and wages of county employees were by proper motion, approved.

The County Engineer spoke to the Board in regard to increasing the hourly wage of Leonard Jella from 40¢ to 45¢ per hour, so that he may receive a wage on the same basis as other employees in that department. He said that the type of work done by Jella merited such an increase.

Chris Schaake moved that the hourly wage of Leonard Jella be increased from 40¢ to 45¢ per hour in line with the other wages received by employees in the Engineering Department. Jas. F. Brass seconded the motion. On vote, called by Chairman Black, all commissioners voted "Aye".

In regard to the purchase of a snow plow for the county, appeared the County Engineer, Alva Hodges and a representative of the Wentz Equipment Company. Because of the extremely cold weather and the impassable conditions of the roads, it was deemed necessary by the Board to purchase such a snowplow. Whereupon, Jas. F. Brass moved that the county purchase from the Wentz Equipment Company, one ten foot snowplow for caterpillar maintainer, at the price of \$565.00, delivered to Lawrence. Chris Schaake seconded the motion. On vote, called by the Chairman, Earl T. Black, all commissioners voted "Aye".
