In regular session this 1st day of April, 1940, a majority of the Board of County Commissioners, namely: Earl T. Black, Chairman and Jas. F. Brass, Commissioner and the County Clerk met in the regular meeting rooms of said Board.

The quarterly report of Stenographer fees of the District Court was approved by the Board and signed by the Chairman. (Amount \$50.00)

By proper motion, second and vote, regular claims against the county for salaries, wages and materials, were approved as recorded on the Allowance Record on file in the office of the county clerk.

The Board adjourned to meet Wednesday, April 3, 1940.

April 3, 1940.

The Board of County Commissioners convened in regular adjourned session, there being present: Earl T. Black, Chairman, Jas. F. Brass, Commissioner and T. R. Gerhart, County Clerk.

The Board placed an order with G. H. Ransom, representative of the Fyr Fyter Company for one fire extinguisher at the price of \$9.50, to be used at the county shops.

More claims against the county were carefully scrutinized and by motion ordered paid as recorded on the Allowance Record.

The County Engineer presented road project No. 301 for Wakarusa Township, to the Board for acceptance. Jas. F. Brass moved that the county accept project No. 301 for Wakarusa Township, for operation under the county blanket to the extent of 3.7 miles of road for grading, drainage and surfacing with crushed rock. Earl T. Black seconded the motion. Motion carried by affirmative vote.

Earl Durbin met with the Board to discuss the eradication of bindweed on his property. Mr. Durbin is not in favor of cultivation and wishes to use chemical on all his land, although it has been the policy of the county to use sodium chlorate only on a quarter acre or less unless on rocky ground or around fences. No action taken this day.

The Board adjourned to meet Saturday, April 6, 1940.

April 6, 1940.

A majority of the Board of County Commissioners and the County Clerk met in regular adjourned session in the regular meeting rooms of said Board.

Earl Durbin met with the Board and Asa R. Colman, County Bindweed Supervisor, for a discussion on the eradication of bindweed on his property. Mr. Durbin refused to consider a cultivation method of killing the bindweed and states that he will use chemicals only. The Supervisor does not believe the chemical method is feasible in this case. No definite action.

By motion, second and vote, the following Cancellation Order was passed:

No. 197:

*** To correct erroneous description of property in Willow Springs Township, Section Eleven, Township Fourteen, Range Nineteen, recorded on the tax rolls for years as indicated below. The error occurred first in 1912 when the phrase "13 acres more or less in the following description" was omitted in copying the property descriptions from the 1911 Assessment Roll. The erroneous description was carried forward on subsequent Assessment and Tax Rolls and this Order is drawn for the purpose of correcting such erroneous descriptions. The correct description should read "Less SE 13 acres more or less of the following: Beg. 40 R W and 45 R N of SE cor of NE 1/4, th N 75 R, W 50 R, S 75 R E 50 R. to beg. in 11-14-19".
