## April 24, 1940.

All members of the Board of County Commissioners, namely: Earl T. Black, Chairman, Jas. F. Brass Commissioner, and J. M. Sanderson, the newly appointed commissioner, met in the regular meeting rooms of said Board in adjourned regular session; there being present, also, T. R. Gerhart, County Clerk.

The Bindweed Supervisor, Asa R. Colman, reported to the Commissioners that he was in need of about 200 pounds of sodium chlorate for the treatment of bindweed. Jas. F. Brass moved that the Bindweed Supervisor be instructed to purchase 200 pounds of chemical for spot treatment on previous treated fields, the landowner or temant to make the application, of if done by the supervisor he is to make a charge of 50¢ per hundred pounds for applying same. J. M. Sanderson seconded the motion. On vote, motion carried by affirmative vote.

No further business appearing, the Board adjourned to meet Saturday, April 27, 1940, at the hour of 9 o'clock A. M.

A delegation mot with the Board to discuss the matter of a settlement between the county and the Kansas City, Kaw Valley and Western Railroad Co., in regard to delinquent taxes and bridge rentals. Those present were: John Brand, Glenn Charlton, Will Pendleton, Art Weaver, C. E. Russell, Robt. Rankin, C. B. Holmes, Chas Radcliffe, Richard Learmonth, W. R. Taylor, Chas. Wise, Alfred Heck, Emil Heck, Gerald Hesse, Frank Leonhard, John S. Tough and George Hedrick.

These men were here for the purpose of presenting arguments to the Board, urging said Board to come to some agreement with the Kansas City, Kaw Valley and Western Railroad, so that the "junking" of said road may be avoided.

It was the consonus of opinion of this committee that a settlement for the payment of taxes along the Arkansas Valley plan would be fair. This plan is one in which on the payment of the current tax, the farthest delinquent year's taxes would be cancelled on the payment of \$100.00for the total tax. This procedure would be continued until all taxes in delinquency has been taken care of. It was, also, suggested by the committee that a bridge rental charge of 50¢ for each loaded freight car crossing the bridge over the Kaw River would be more than fair. However, the Board of County Commissioners was of the opinion that the charge of \$1.00 for each loaded freight

NOW, THEREFORE, BE IT RESOLVED that the applicant, Lawrence Country Club by Vaughn C. Pontius, Managor, be granted a license to soll coreal malt bevorages for consumption on premises at the place so described in application.

BE IT FURTHER RESOLVED that T. R. Gerhart, County Clerk of Douglas County, bc, and he is hereby directed to issue said license.
