Jas. F. Brass moved that the potition of Wm. H. Martin et al for the temporary closing of a road described above, be accepted, and that the date of viewing be set for May 23, at 2 o'clock P. M. J. M. Sanderson seconded the motion. On vote, called by Chairman Black, all members voted "Aye".
