It was asked if the county would allow the use of the welfare truck to transport these boys who will work on this survey. The Board had no objection to this, if the truck was not being used for other work. Mr. Henderson asked if the tools and truck wore furnished, would the county be willing to furnish the gasoline for said truck. The Board gave its okay to the furnishing of gasoline.

A discussion was gone into by the Board with Milton Beach and Roy Flory, County Attorney, in regard to the Judicial Tax Sale. After some discussion pro and con, Jas.F. Brass moved that the Board authorize the County Attorney to prepare a resolution to proceed with the Judicial Tax Sale. J. M. Sanderson seconded the motion. On vote, called by Chairman Black, all commissioners voted "Aye".

W. E. Spalding, again, appeared before the Board in regard to personal property assessments. In regard to the Williams-Roberts' assessment, Mr. Spalding told the Board that he had formerly In regard to the williams-notice assessment, Mr. Spaling that he heat to he had tormerly suggested they look into this matter for its own information. Mr. Spaling, also, denied that he had previously asked the Board to call anybody "on the carpet" or have any assessment raised. How-ever, the Commissioners informed him that it was their understanding that he wished for the assessment to be raised. It was remarked by Mr. Spalding that it wasn't his intention that any assessments be raised, but it was his thought to give a report on that which was unequal. In fact, he never thought the Commissioners would raise any assessments, at all. He, also, is not satisfied with the way the merchant's stock statements are being used by the assessors. He contends they are not being used as much as they should be. Mr. Spalding said he still thought that personal property assessments on the merchants in town are too low.
