In adjourned regular session this 19th day of June, 1940, there met in the regular meeting rooms of the Board of County Commissioners, all members of said Board, namely, Earl T. Black, Chairman, Jas. F. Brass and J. M. Sanderson, Commissioners and T. R. Gerhart, County Clerk.

It was the unanimous approval of the Board that the county take over and maintain the two mile stretch of the Vinland-Clearfield road, lying between Sections 9 and 16 and Sections 10 and 15, Township 14, Range 21, in Douglas County; Johnson County agreed to maintain said road as it extended over into that county.

Asa Colman, Bindweed Supervisor, talked to the Board about the request of Earl Durbin for chemical to eradicate the bindweed on his property. It was advised by the Supervisor that Mr. Durbin use the cultivation program, because of the large acreage of bindweed; however, Mr. Durbin refuses to do this and insists on using the chemical. According to a communication received from Warden L. Noe, Attorney for the State Board, the county can be compelled to sell sodium chlorate at half price to any citizen who wishes to buy same for the eradication of bindweed on his property.

All members of the Board of County Commissioners and the County Clerk met in adjourned regular session.

The following resolution in regard to the residue sales tax was passed by the Board:

RESOLUTION

WHEREAS, there was received on June 15, 1940, the residue sales tax apportionment from the Retailers Sales Tax Fund, for Douglas County taxing units, and

WHEREAS, the share due Douglas County, as a taxing unit, is \$16,557.60, and

WHEREAS, it is provided in Chapter 334 of Session Laws of 1939, that the Board of County Commissioners may, by resolution, direct the County Treasurer to credit all or any portion of the county's share of such sales tax distribution as a political subdivision, to the County Social Welfare Fund.

THEREFORE, BE IT RESOLVED by the Board of County Commissioners of Douglas County, Kansas, this 22nd day of June, 1940, that the County Treasurer be instructed to transfer from the Residue Sales Tax Fund to the County Social Welfare Fund, the amount of \$16,557.60.

Jas. F. Brass moved that the foregoing resolution be adopted. J. M. Sanderson seconded the motion. On vote, all commissioners voted "Aye".

Pursuant thereto, the following order was approved:

No. 1894-1940 Pursuant to resolution, passed by the Board of County Commissioners, this 22nd day of June, 1940, the County Treasurer is, hereby, instructed to transfer from the Residue Sales Tax Fund to the County Social Welfare Fund, the amount of \$16,557.60, as provided in Chapter 334, Session Laws of 1939."

John Schopper, again, met with the Board to discuss his property in Eudora, located within the City limits. Mr. Schopper said that the City Council of Eudora would discuss the probability of changing this land to lots, so the assessment could be made on a lot basis. The Chairman of the Board said that if the City of Eudora wanted to pass a resolution in regard to keeping this property
