July 24, 1940.

The Board of County Commissioners, with all members present, ^{except Earl T. Black} met in the regular meeting rooms of said Board as per adjournment. T. R. Gerhart, County Clerk, was, also, present.

Considerable discussion was given to the opening of the Lone Star Lake. Lathrop Read, Jr., Under Sheriff, and Charles E. Banning, Sheriff spoke on the safety problem on the day of the opening. The Board placed this entire matter into the hands of the Sheriff's office. It was suggested that a motor boat be secured for first aid; also, that a telephone be installed; that the stumps along the water line be flagged, and that the cars be parked on the lake side of the road.

The following Cancellation Order was passed:

No. 191: " TO CANCEL dog tax erroneously assessed to Mrs. John Dunn of Clinton Township, School Dist. #22. Dog was killed in December prior to March assessment."

July 25, 1940.

In regular adjourned session, there met all members of the Board of County Commissioners and the County Clerk.

Harry Gregg met with the Board to discuss his application as Care Taker of the Lone Star Lake. He said that with the time he would have to put in on such a job, he thought he should receive as much as the Care Taker had at the State lake, which is \$75.00 per month. It was the thought of the Board, however, that the county would pay \$60.00 per month, furnish the house and, also, allow Mr. Gregg to gather his own wood from that on the park grounds. Whereupon, the following motion was made:

Jas. F. Brass moved that the application of Harry S. Gregg as Care Taker for the Lone Star Lake, be accepted at the monthly wage of \$60.00 per month, starting August 1, 1940 and terminating February 1, 1941; that the county wire the house and supply the electricity, Mr. Gregg to reimburse the county on said electricity in the amount of \$2.50 per month; also, that Mr. Gregg be allowed to gather his own fuel from the park area. J. K. Sanderson seconded the motion. On vote, all commissioners voted "Aye".

The Board agreed to furnish gasoline for the Care Taker's car, to be used in patrolling the lake.

Mr. John Selzer and Son appeared before the Board and Acting County Engineer to discuss road improvements for a road going through the south side of his place. Mr. Stephens, Acting County Engineer said that he would figure the costs on same and present at a later date.

With Mildred LeSuer, Budget Director, the Commissioners entered into a discussion for the 1941 budget.

Roy Flory, County Treasurer, asked the Board to consider paying 35¢ per hour to his clerical help.

The following agreement was entered into with A. S. Elliot, in regard to the concession rights

A G R E E M E N T

THIS AGREEMENT made this 25th day of July, 1940, by and between the Board of County Commissioners of Douglas County, Kansas, party of the first part, and A. S. Elliot of Lawrence, Kansas, Douglas County, Kansas, party of the second part.

WITNESSETH that the said party of the first part in consideration of the agreements of the party of the second part hereinafter stated, agrees and covenants with the said party of the second part to grant to the said party of the second part the exclusive right to maintain concessions at the Douglas County Lake located at Lone Star, Kansas, said concessions being the following:
A. Boating concession, B. Fishing bait concession, C. Eating and soft drinks concession, D. Fishing supplies and sundry items.
