December 11, 1940.

All members of the Board of County Commissioners and the County Clerk convened in regular adjourned session.

Mr. Moore, Salesman for the Williams-Roberts Motor Company, again, appeared before the Commissioners to discuss the purchase of a car for the Sheriff's office. He stated that if the Board could purchase this car within the next sixty days, it could save considerable money on the deal, since the price of automobiles is going up. The Commissioners wished to discuss this with the Sheriff.

The Board passed the following orders:

No. 202*** CANCEL 1940 Personal Property tax in the amount of \$9.45, based on an intangible valuation of \$1890.00, charged to Fred Copp, 929 N. Y. St., Lawrence.

Assessor DeWolf erred in assessing Mr. Copp for a mortgage Mr. Copp owes on his property.

No. 203*** CANCEL 1940 Personal Property tax in the amount of \$7.60, based on a tangible valuation of \$200.00, charged to Alfred Berg, 1137 Kentucky, Lawrence.

Constitutional exemption of \$200.00 should have been allowed in Douglas County. Note certified letter that same was not taken in Marion County where Mr. Berg was also assessed for other property.

Dr. H. Penfield Jones presented the application of Dr. J. R. Bechtel for admission to the T.B. Sanitorium at Norton, Kansas, for treatment. Dr. Jones said that it was the plan to have Dr. Bechtel accepted as a County patient, and then he was to reimburse the county \$1.00 per day for cost of treatment. J. M. Sanderson moved that the county accept said Dr. J. R. Bechtel as a county patient for admittance to the State T. B. Sanitorium for treatment, with the understanding that the patient would reimburse the county \$1.00 per day, which is the cost to the county for such treatment. Jas. F. Brass seconded the motion. On vote, called by Chairman Black, all commissioners voted "Aye".

On the motion of J. M. Sanderson, second of Jas. F. Brass and unanimous vote of the Board, the following resolution was passed:

RESOLUTION

WHEREAS, Section 79-2422, General Statutes, 1935, grants authority to the Board of County Commissioners to compromise taxes, interest and penalties on any land or lots which have been bought in by the County and which have been unredeemed for at least a period of four years; and

WHEREAS, there now appears Trustees of St. Lukes A.M.E. Church, owner of the following described property:

Lot 54, New York,

on which taxes are due and unpaid for the years 1933, 1934, 1935, 1936, 1937 and 1938, as shown on the tax sale records of Douglas County, and

WHEREAS, it is the wish of the Board of County Commissioners of Douglas County, Kansas, to extend to the above owner of the above described property a right to moratorium privileges similar to those provided in Chapter 326, Session Laws of Kansas for 1939.

NOW, THEREFORE, BE IT RESOLVED by the Board of County Commissioners of Douglas County, Kansas, that when taxes for the year 1938 and subsequent years have been paid, said above owner may redeem the above described property now appearing on the tax sale books of Douglas County without paying the penalties, costs or expenses, which are hereby remitted, and by paying interest on such back tax at the rate of six per centum per annum from September 1, 1939.
