The following beer resolutions were passed:

RESOLUTION

WHEREAS, on the 26th day of December, 1940, the same being a regular adjourned meeting of the Board of County Commissioners, the application of Melvin M. Molder for a beer license came on for consideration of said Board, and

WHEREAS, the Board does find that the said Melvin M. Molder is in all ways qualified under the law to sell cereal malt beverages for consumption on the premises, and

WHEREAS, the Board further finds that due and legal notice has been given to the Wakarusa Township Board and that ten days have expired from the giving of said notice, and that no written objection has been filed by the Wakarusa Township Board, protesting the granting of a beer license.

NOW, THEREFORE, BE IT RESOLVED that the applicant Melvin M. Molder be granted a license to sell cereal malt beverages for consumption on premises at the place so described in application.

BE IT FURTHER RESOLVED that T. R. Gerhart, County Clerk of Douglas County, be, and he is hereby directed to issue said license.

RESOLUTION

WHEREAS, on the 26th day of December, 1940, the same being a regular adjourned meeting of the Board of County Commissioners, the application of Cecil Jardon for a beer license came on for consideration of said Board, and

Although E. E. Trueblood, County Engineer, has not officially resigned from said position, it is understood that he will not return to take up his work, and since he has moved from the county, the Board thought it wise to consider appointing John E. Stephens, who is now Acting County Engineer, as Engineer of Douglas County. Pursuant thereto, Jas. F. Brass moved the adoption of the following resolution. Earl T. Black seconded the motion, and on vote, said motion carried:

RESOLUTION

WHEREAS, it appears to the Board of County Commissioners of Douglas County, Kansas, that the Douglas County Engineer and Surveyor, E. E. Trueblood, is no longer active in that capacity, and although he has not officially resigned, he has moved away from the county for an indefinite period of time, and does not draw a salary from Douglas County;

AND WHEREAS for the purposes of clarifying the official acts, duties, and responsibilities of the office of County Engineer, it is necessary that some person be officially designated as County Engineer and Surveyor of Douglas County, Kansas;

AND WHEREAS, John E. Stephens, who has been employed as assistant county engineer of Douglas County, and during Mr. Trueblood's absence, has been acting county engineer;

THEREFORE BE IT RESOLVED by the Board of County Commissioners of Douglas County, Kansas, on this 26th day of December, 1940, that John E. Stephens be and he is hereby appointed and designated as County Engineer and Surveyor of Douglas County, Kansas, said appointment to be effective on the 16th day of December, 1940, and continue until the return of Mr. Trueblood in the active capacity of County Engineer and Surveyor, or until his tenure of office is otherwise terminated by a majority vote of the Board of County Commissioners of Douglas County, Kansas.

BE IT FURTHER RESOLVED that Mr. Stephens shall receive compensation for his services as County Engineer and Surveyor, in the sum of \$175.00 until the first of January, 1941, at which time the Board of County Commissioners will consider and determine a permanent rate of compensation to be paid.
